Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- SECTION 1. Chapter 63 of the Acts of 2007 is hereby amended by striking out section
- 2 15.
- 3 SECTION 2. Chapter 158 of the Acts of 2005 is hereby amended by striking out section
- 4 9 and inserting in place thereof the following: -
- 5 "This act shall be effective for tax years beginning on or after January 1, 2006."
