An Act relative to equitable pay at quasi-public agencies.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

2	SECTION 1. Chapter 29 of the general laws is hereby amended by inserting after section
3	218 the following new section:-
4	Section 219 (a). No at-will employees of any state authority, as defined in section 1 of
5	chapter 29, may be provided compensation in salary or wages in excess of the salary provided to
6	the Governor of the Commonwealth, as set forth in section 1 of chapter 6, as so appearing.
7	(b). No state authority, as defined in section 1 of chapter 29, may enter into a contract,
8	executed after the passage of this act, with any employee that provides compensation in salary or

9 wages in excess of the salary provided to the Governor of the Commonwealth, as set forth in10 section 1 of chapter 6, as so appearing.

- 11 (c). All state authorities, as defined in section 1 of chapter 29, shall submit by December 12 31, 2017, to the Senate and House Committees on Ways and Means a compensation reduction 13 report that shall include, but not be limited to, a plan that details all percentage salary reductions, 14 wage freeze, furloughs and reduction of employees including attrition. 15 (d). A state authority may provide compensation in excess of the amount referenced in 16 sections (a) and (b) of this chapter, provided that the authority: 17 (1) provides notice to the governor, treasurer, auditor, senate and house ways and 18 means committee, and senate and house post-audit and oversight committee setting forth reasons 19 for excess compensation; 20 (2) publish said notice to the general public;
- 21 (3) provides a 30 day public comment period and conducts a public hearing on
 22 said compensation
