**In the One Hundred and Ninety-Third General Court
(2023-2024)**

An Act relative to rolling stock.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Section 1 of chapter 64H of the general laws, as appearing in the 2020
2 Official Edition, is hereby amended by inserting, after the definition of “Retail establishment”,
3 the following definition:-

4 “Rolling stock”, trucks, tractors, and trailers, used by common carriers to transport goods
5 in interstate commerce.

6 SECTION 2. Section 6 of chapter 64H, as so appearing, is hereby amended by inserting,
7 after subsection (xx), the following new subsection:-

8 (yy) Sales of rolling stock.

9 SECTION 3. Section 1 of chapter 64I, as so appearing, is amended by inserting in line 5,
10 after the words “retail establishment”, the following new words:- , “rolling stock”.

11 SECTION 4. Section 7 of chapter 64I, as so appearing, is hereby amended by inserting,
12 after subsection (e), the following new subsection:-
13 (f) Storage, use, or other consumption of rolling stock.
