## The Commonwealth of Massachusetts

In the Year Two Thousand Fifteen

Resolve establishing a special legislative commission on young professionals

Resolved, Notwithstanding any general or special laws to the contrary, there shall be a special commission on young professionals established to examine how the commonwealth can better engage, involve and educate young professionals in decisions and policies that affect them and the commonwealth. The commission will examine best practices and policies to retain and attract intellectual capital that will make Massachusetts a place where young professionals want to live, work and play.

The commission shall consist of 20 members, 1 of whom shall be the secretary of 7 housing and economic development or a designee, 1 of whom shall be the secretary of labor and 8 workforce development or a designee, 1 of whom shall be the secretary of education or a designee, 2 of whom shall be appointed by the president of the senate; 1 of whom shall be 10 appointed by the minority leader of the senate, 2 of whom shall be appointed by the speaker of 11 the house of representatives, 1 of whom shall be appointed by the minority leader of the house of 12 representatives, and 11 of whom shall be appointed by the governor as representatives of young 13 14 professionals networks or economic development networks in the commonwealth, including the President of the Greater Lawrence Young Professionals Network or a designee, the President of 15

The special commission may receive and expend grants, gifts, contributions, bequests and in-kind contributions, including volunteer services, from individuals, corporations or other business entities, foundations and state or other government bodies for the purpose of completing its report.
