## The Commonwealth of Massachusetts

In the Year Two Thousand Eleven

An Act relative to the administrative organization of financial officers .

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 Section 1. Section 10 of Chapter 169 of the Acts of 1881 is hereby amended by striking
- 2 out the first five sentences and inserting in place thereof the following:

Section 3. Chapter 446 of the Acts of 1950 is hereby amended by striking out Section 1 37 of said act and inserting in place thereof the following: ?Upon passage of this act, the City 38 Council may, as soon as practicable, choose by majority vote a Treasurer, who shall serve until 39 40 December 31, 2011, unless sooner removed for cause. Commencing in January of 2012 and every three years thereafter, the City Council shall choose by majority vote a 41 Treasurer who shall serve for the three years next ensuing and until a successor is appointed 42 43 and qualified; provided that he may be removed by the City Council at any time for sufficient 44 cause. Any 45 □vacancy occurring in such office may be filled at any time by majority vote of the City 46 Council. The 47 48 □ compensation of the Treasurer shall be fixed by ordinance. The Treasurer shall have all the powers and duties imposed by law and ordinance on municipal 49 □ treasurers and collectors of taxes and shall serve as Chief Financial Officer for the city. 50 51 □ As Chief Financial Officer, his duties shall include administering, coordinating and supervising 52 all 53 □ financial services, activities and officers, and assisting in all matters relating to municipal 54 financial □ affairs.
