Senate, January 23, 2012 – New draft of Senate, No. 215 reported from the committee on the Education.

## The Commonwealth of Massachusetts

In the Year Two Thousand Twelve

An Act establishing the afterschool and out-of-school time coordinating council.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. There is hereby established the Massachusetts afterschool and out-of-school  
2 time coordinating council, to consist of 15 members: 2 members from the legislature, 1 of whom  
3 shall be a member of the house of representatives, to be appointed by the speaker of the house,  
4 who shall serve as co-chair, and 1 of whom shall be a member of the senate, to be appointed by  
5 the senate president, who shall serve as co-chair; 1 representative from the department of  
6 elementary and secondary education to be appointed by the commissioner of elementary and  
7 secondary education; 1 representative from the department of early education and care to be  
8 appointed by the commissioner of early education and care; 1 representative from the department  
9 of higher education to be appointed by the commissioner of higher education; 1 representative  
10 from the department of children and families to be appointed by the commissioner of children  
11 and families; 1 representative from the department of public health to be appointed by the  
12 commissioner of public health; and 8 members who shall be appointed by the governor, 2 of

13 whom shall be representatives from community-based organizations that serve state subsidized  
14 children in their afterschool and out-of-school time programs, 1 of whom shall be a  
15 representative from the Board of Library Commissioners, 1 of whom shall be a superintendent of  
16 schools whose district offers afterschool and out-of-school time programs, 1 of whom shall be a  
17 representative of private funders supporting afterschool and out-of-school time programs, 1 of  
18 whom shall be a representative from the Massachusetts Afterschool Partnership, 1 of whom shall  
19 be a representative from the governor's youth council, and 1 of whom shall be a parent or  
20 guardian of a child who benefits from the services of afterschool and out-of-school time  
21 programs.

22 Council members shall be appointed for a term of 4 years. The council shall conduct its  
23 first meeting not more than 60 days after the effective date of this act. The council shall evaluate  
24 the progress of its efforts not later than 4 years after the first meeting and shall disband unless a  
25 majority of the members recognize a continuing need for the council to exist.

26 The council shall consult with and solicit input from various persons and groups,  
27 including, but not limited to: the Massachusetts school building authority; the Massachusetts  
28 Association of School Superintendents; Massachusetts Elementary School Principals  
29 Association; the Massachusetts Association of School Committees; the American Federation of  
30 Teachers- MA; the Massachusetts Teacher Association; the Massachusetts Association of Early  
31 Education and Care; and the Governor's Child and Youth Readiness Cabinet.

32 The council shall review existing state and local programs and policies on afterschool and  
33 out-of-school time programs and make recommendations to the department of early education

34 and care, the department of elementary and secondary education, and the department of higher  
35 education on model approaches regarding, but not limited to, the following areas:

36 (a) the alignment of efforts between the department of early education and care, the  
37 department of elementary and secondary education, and the non-profit sector on afterschool and  
38 out-of-school time programs; (b) opportunities for coordination and collaboration between  
39 school districts and community-based afterschool and out-of-school time programs; (c) methods  
40 for improving quality and retention in the afterschool and out-of-school time workforce,  
41 including enhancing opportunities for professional development and technical assistance; (d)  
42 methods to increase access for all children and families to high quality afterschool and out-of-  
43 school time programming; and (e) public and private support to build a sustainable infrastructure  
44 for afterschool and out-of- school time programs.

45 SECTION 2. The department of early education and care, the department of elementary  
46 and secondary education, the executive office of health and human services, the executive office  
47 of public safety, the department of developmental services, the department of children and  
48 families, and the department of labor and workforce development shall each report to the council  
49 a description of all state and federal funding expended on afterschool and out-of-school time and  
50 the programs such funding supports on or before September 1 for each year that the council  
51 exists.

52 SECTION 3. The council shall meet 4 times annually. The Massachusetts Afterschool  
53 Partnership, under the oversight of the Executive Office of Education, shall appoint personnel  
54 necessary to coordinate the activities of the council and provide administrative support to the  
55 council, as requested.

56           The council shall prepare and submit an annual progress report concerning the council's  
57 activities with appropriate recommendations concerning afterschool and out-of-school time  
58 programs to the governor and the clerks of the senate and the house of representatives, who shall  
59 forward the same to the chairs of the joint committee on education and the chairs of the house  
60 and senate committees on ways and means on or before December 31 for each year that the  
61 council exists.
