Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- SECTION 1. Section 28 of Chapter 7 of the General Laws as appearing in the 2012
- 2 Official Edition is hereby amended in line 24 by inserting after the word "meals" the following
- 3 words:-
- 4 "lodging, entertainment, airfare and other travel expenses"
- 5 SECTION 2. Section 28 of said Chapter 7 is hereby amended in line 26 by inserting after
- 6 the word "thereof" the following words:- "or at the expense of any fund created by the
- 7 commonwealth"
- 8 SECTION 3. Section 28 of said Chapter 7 is hereby amended in line 27 by striking out
- 9 the following words:- "which receive state appropriations."
- SECTION 4. Section 29 of said Chapter 7 is hereby amended by striking lines 71-75 in
- 11 their entirety.
