Nguyen (by vote of the town) for legislation relative to the granting of alcoholic beverages licenses in the town of Boxford. Consumer Protection and Professional Licensure. **In the One Hundred and Ninety-First General Court
(2019-2020)**

An Act relative to the granting of alcoholic beverages licenses in the town of Boxford.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Notwithstanding section 17 of chapter 138 of the General Laws, The Board
2 of Selectmen as the licensing authority of the town of Boxford may grant one (1) additional
3 license for the sale of wines and malt beverages to be drunk on the premises pursuant to section
4 12 of said chapter 138 to Boxford Community Store, Inc., located at 7 Elm Street, and one (1)
5 additional license for the sale of wines and malt beverages to be drunk on the premises pursuant
6 to said section 12 of said chapter 138 to a restaurant located in the B-1 Retail Business District
7 upon successful application to the Board of Selectmen. Licenses granted under this act shall be
8 subject to all of said chapter 138, except said section 17. If any license granted pursuant to this
9 act is cancelled, revoked or no longer in use, it shall be returned physically, with all of the legal
10 rights, privileges and restrictions pertaining thereto, to the licensing authority, which may then
11 grant the license to a new applicant at the same location, or at another location in the B-1 Retail
12 Business District under the same conditions as specified in this act.

13 SECTION 2. Notwithstanding section 11 of chapter 138 of the General Laws or any other
14 general or special law to the contrary, the licensing authority of the town of Boxford may grant
15 special licenses for the sale of alcoholic beverages in accordance with section 14 of chapter 138
16 to a responsible manager conducting an indoor or outdoor activity or enterprise for a gathering of
17 less than 500 persons. The licenses shall be subject to any other requirements that the Board of
18 Selectmen may deem appropriate.
