An Act to extend veterans retirement buyback opportunities.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           Section 4 of chapter 32 of the General Laws is hereby amended by striking out, in line  
2 158, as appearing in the 2016 Official Edition, the words “four years provided” and inserting in  
3 place thereof the following figure:- 10 years; provided.
