## The Commonwealth of Massachusetts

In the One Hundred and Ninety-First General Court (2019-2020)

An Act relative to individuals with intellectual or developmental disabilities.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 SECTION 1. This act may be referred to as Katie's Law.
- 2 SECTION 2. Section 172C of chapter 6 of the General Laws, as appearing in the 2018
