An Act establishing a selectmen-administrator form of government for the town of Newbury.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Upon the effective date of this act, the town of Newbury shall be governed  
2 by this act. To the extent that this act modifies or repeals existing General Laws and special acts  
3 or that body of law which constitutes the town charter under Section 9 of Article LXXXIX of the  
4 Amendments to the Constitution of the Commonwealth, this act shall govern.

5           SECTION 2. The administration of all of the fiscal, prudential, and municipal affairs of  
6 the town shall remain vested in the executive branch headed by the board of selectmen and the  
7 legislative powers of the town shall remain vested in a town meeting open to all voters.

8           SECTION 3. The board of selectmen shall appoint the chief of police and all other police  
9 officers, the town counsel, the administrative assistant to the selectmen, the members of the  
10 human resources board, the members of the zoning board of appeals, the members of the finance  
11 committee, 2 members of the capital planning committee, the fire chief, and all the members of

12 other appointed boards, committees, and commissions except as may be otherwise specified in  
13 this act.

14 SECTION 4. The regional school committee members shall continue to be elected in  
15 conformity with the votes of the regional school district All powers, rights and duties, now or  
16 hereafter conferred or imposed by law upon the regional school committee, shall be exercised  
17 and performed by the regional school committee. This act shall not be construed to affect the  
18 powers and duties of the regional school committee as provided by law.

19 SECTION 5. A member of the board of selectmen, or of the regional school committee,  
20 or of the finance committee, during the term for which the member was elected or appointed,  
21 shall be ineligible either by election or appointment to hold any other town office. Any other  
22 person appointed by the selectmen or town administrator to a town office under this act or of any  
23 general or special law shall be eligible during the term of said office to appointment to any other  
24 town office, except that the town accountant shall not be eligible to hold the position of town  
25 treasurer or the position of town collector. The town administrator, subject to applicable General  
26 Laws relating thereto, may assume the duties of an office which he is authorized to fill by  
27 appointment.

28 SECTION 6. The selectmen elected as provided herein shall appoint, as soon as  
29 practicable, for a definite term to be set by the selectmen, a town administrator who shall be a  
30 person especially fitted by education, training, and experience, to perform the duties of the  
31 office. The town administrator shall be appointed without regard to political affiliations or  
32 beliefs. The town administrator need not be a resident of the town or of the commonwealth, shall  
33 possess a college degree at the bachelor level and shall have 3 years of full-time paid experience

34 in a supervisory administrative position. A master's degree may substitute for not more than 1  
35 year of such paid experience. The town administrator shall execute a bond in favor of the town  
36 for the faithful performance of the duties of the office in a sum and with such surety or sureties  
37 as fixed or approved by the selectmen, the cost of which shall be paid by the town. The  
38 selectmen shall enter into a formal contract with the town administrator and establish a  
39 compensation and benefits package which may take precedence over any personnel by-laws.

40 SECTION 7. A vacancy in the office of town administrator shall be filled as soon as  
41 possible by the selectmen. Pending the appointment of a town administrator or filling of a  
42 vacancy, the selectmen shall, within 7 days, appoint a suitable person to perform the duties of the  
43 office.

44 SECTION 8. The town administrator may designate, subject to approval by the board of  
45 selectmen, by letter filed with the town clerk, a qualified officer of the town to perform the duties  
46 of the office during a temporary absence or disability of the town administrator. In the event of  
47 failure of the town administrator to make that designation, the selectmen may, by resolution,  
48 designate an officer of the town to perform the duties of the office until the town administrator  
49 shall return or the disability shall cease.

50 SECTION 9. During any term of appointment of the administrator, the board of  
51 selectmen may, under the terms and conditions of the contract entered into between the town and  
52 the administrator as set forth in section 6, remove the administrator for good cause. In the event  
53 of such removal, the administrator shall receive a severance pay in the amount equal to 1 month  
54 of pay for each full year of service to the town, but in no event more than an amount equal to 3  
55 months' pay.

56 SECTION 10. The town administrator shall receive such compensation for services as the  
57 board of selectmen shall determine, but the compensation shall not exceed the amount  
58 appropriated therefore by the town.

59 SECTION 11. In addition to specific powers and duties provided in this act, the town  
60 administrator shall have the general powers and duties enumerated in this section as follows:

61 (1) The town administrator shall supervise the heads of all departments and shall  
62 supervise and direct the general administration of all commissions, boards, and offices, except  
63 the board of selectmen, the regional school committee, the planning board, the board of health,  
64 the board of assessors, the finance committee, the library trustees, the town counsel, and the  
65 moderator. The town administrator shall not exercise any control over the discretionary power  
66 vested by statute in any such board, committee, commission, or office.

67 (2) The town administrator, in accordance with this act and with the approval of the board  
68 of selectmen, except as otherwise expressly prohibited by the General Laws, may reorganize,  
69 consolidate, or abolish departments, commissions, boards, or offices under his direction and  
70 supervision, in whole or in part, and may establish such new departments, commissions, boards,  
71 or offices as the town administrator considers necessary and may transfer the powers and duties  
72 of one department, commission, board, or office to another.

73 (3) The town administrator shall approve, upon the recommendation of department heads,  
74 the appointment and removal of all officers and employees of the town. Department heads shall  
75 select, on merit and fitness alone, all department employees for such recommendation. The town  
76 administrator shall appoint on merit and fitness alone, and may remove, all officers and  
77 employees of the town who are not otherwise appointed or elected under this act.

78 (4) The town administrator shall attend all regular meetings of the board of selectmen.

79 (5) The town administrator shall keep full and complete records of the office, and shall  
80 render as often as may be required by the selectmen, but, in any case, annually, a full report of all  
81 operations during the period reported on.

82 (6) The town administrator shall keep the selectmen fully advised as to the needs of the  
83 town and shall recommend to the selectmen for adoption measures requiring action by them or  
84 by the town as the town administrator considers necessary or expedient.

85 (7) The town administrator shall have jurisdiction over the rental and use of town  
86 property and shall be responsible for the maintenance and repair of town buildings. The town  
87 administrator shall be responsible for the preparation of plans and the supervision of work on  
88 existing town buildings and on the construction of new town buildings.

89 (8) The town administrator shall appoint the chief procurement officer of the town who  
90 shall be responsible for the purchase of all supplies and materials and equipment, except books  
91 and educational materials for schools and books and other media for libraries, and shall approve  
92 the awards of all contracts for all departments of the town. The chief procurement officer may  
93 hold other positions with the town consistent with the officer's role hereunder.

94 (9) The town administrator shall administer, either directly or through a person appointed  
95 by the town administrator in accordance with this act, general and special laws applicable to the  
96 town, all town by-laws and all regulations established by the selectmen.

97 (10) The town administrator shall have authority, with the approval of the board of  
98 selectmen and the town counsel, to prosecute, defend and compromise all litigation to which the

99 town is a party, and shall be the executive officer of a public employer in the town as referred to  
100 in chapter 258 of the General Laws pertaining to the processing of claims against the town.

101 (11) The town administrator shall be the selectmen's agent for collective bargaining and  
102 may request the town counsel to assist in the performance of these duties.

103 (12) The town administrator shall secure on or before December first of each year from  
104 all offices, boards, and committees charged with equipment, a list of the equipment upon forms  
105 approved by the finance committee. The lists shall be filed with the town accountant who shall  
106 transmit them to the clerk of the finance committee.

107 (13) The town administrator shall attend town meetings and shall be permitted to speak  
108 when recognized by the moderator.

109 (14) The town administrator shall be responsible for the implementation of town meeting  
110 votes and shall report annually in writing to the town meeting on the status of prior town meeting  
111 votes on which implementation is not complete.

112 (15) The town administrator shall be accessible and available during regular office hours  
113 for consultation to chairpersons of boards, committees, and commissions of the town, whether  
114 appointed or elected, and shall make accessible and available to them data and records of the  
115 office of town administrator as may be requested in connection with their official duties.

116 (16) The town administrator shall perform such duties, consistent with the office, as may  
117 be required by the by-laws of the town or by vote of selectmen or town meeting.

118 SECTION 12. The town administrator may, without notice, cause the affairs of any  
119 division or department under his or her supervision, or the job-related conduct of any officer or

120 employee thereof, to be examined. The town administrator shall have access to all town books  
121 and papers for information necessary for the proper performance of the town administrator's  
122 duties. The town administrator shall promptly transmit any findings of wrongdoing to the board  
123 of selectmen.

124 SECTION 13. The town administrator shall appoint, with the approval of the board of  
125 selectmen, the town treasurer, the tax collector, the town accountant, the building inspector and  
126 assistant building inspector, the conservation agent, the public works director, the harbormaster,  
127 the town planner, the director of veterans' affairs, the assistant town accountant, the  
128 administrative assistant, the IT/communications program manager, the production/operations  
129 specialist, the principal assessor, and the assistant assessor. The town administrator shall appoint,  
130 and may remove subject to the approval of the board of selectmen, department heads, officers,  
131 and subordinates and employees for whom no other method of appointment is provided in this  
132 act, except the assistant town clerk, who shall be appointed by the town clerk, and persons  
133 serving under other elected agencies and appointments made by representatives of the  
134 commonwealth. Appointments to the permanent positions made by the town administrator shall  
135 become effective on the fifteenth day following the day notice of appointment is filed with the  
136 board of selectmen, unless the board of selectmen shall, within that period, by a majority vote of  
137 the full board, vote to reject any such appointment.

138 SECTION 14. The registered voters of the town of Newbury shall, in accordance with  
139 applicable laws, town by-laws, and votes of the town, continue to elect the following:

140 (1) moderator;

141 (2) members of the board of selectmen;



- 142 (3) regional school committee members;
- 143 (4) members of the planning board;
- 144 (5) members of the board of health;
- 145 (6) library trustees;
- 146 (7) town clerk;
- 147 (8) constables;
- 148 (9) fish commissioners;
- 149 (10) trustees of the First Settlers Burial Ground;
- 150 (11) tree warden; and
- 151 (12) members of the board of assessors.

152 This act shall not affect the term of office of an elected official or elected member of a  
153 board, committee or authority. Every other elective office, board, committee, or commission of  
154 the town shall be terminated or shall become appointive as provided herein, any other law to the  
155 contrary notwithstanding. The term of office of a person elected to an office, board, committee,  
156 or commission of the town, existing at the time of such acceptance and terminated hereunder,  
157 shall continue until the appointment of the town administrator, and thereafter the offices, boards,  
158 committees, and commissions shall be abolished, and all powers, duties and obligations  
159 conferred or imposed thereon by law, except as provided by this act, shall be conferred and  
160 imposed upon the town administrator to the extent hereinafter provided. The term of office of a  
161 person elected to an office, board, committee, or commission, existing as an elected office on the

162 effective date of this act and having become appointive hereunder, shall continue until the term  
163 for which that person was elected shall have expired, and until the appointment and qualification  
164 of a successor. The powers, duties, and responsibilities of elected officials shall be as now or  
165 hereafter provided by applicable General laws, special acts, town by-laws, and votes of the town,  
166 except as otherwise expressly provided herein. Notwithstanding the election by the voters of the  
167 town of the officers named in this section, those officers shall be available to the administrator  
168 for consultation, conference and discussion on matters relating to their respective offices. The  
169 town administrator may require those officials, except the selectmen, to prepare reports for the  
170 town administrator necessary for the efficient administration of any of the fiscal responsibilities  
171 of the office.

172           SECTION 15. At least 90 days before the annual town meeting, the town administrator  
173 shall submit in writing to the board of selectmen a careful detailed estimate of the probable  
174 expenditures of the town government for the ensuing fiscal year, stating the amount required to  
175 meet the interest and maturing bonds and notes or other outstanding indebtedness of the town,  
176 and showing specifically the amount necessary to be provided for each fund and department,  
177 together with a statement of the expenditures of the town for the same purposes in the preceding  
178 year and an estimate of the expenditures for the current year. The town administrator shall also  
179 submit a statement showing all revenues received by the town in the preceding fiscal year  
180 together with an estimate of the receipts of the current year and an estimate of the amount of  
181 income from all sources of revenue exclusive of taxes upon property in the ensuing year. The  
182 town administrator shall report the probable amount required to be levied and raised by the  
183 taxation to defray all expenses and liabilities of the town, together with an estimate of the tax rate  
184 necessary to raise that amount. For the purposes of enabling the town administrator to make up

185 the annual estimates of expenditures, all boards, offices, and committees of the town shall, at  
186 least 120 days before the annual town meeting, furnish all information in their possession and  
187 submit in writing to the town administrator a detailed estimate of the appropriations required for  
188 the efficient and proper conduct of their respective departments during the next fiscal year.

189 SECTION 16. The board of selectmen shall consider the tentative budget submitted by  
190 the town administrator and make recommendations relative thereto as it considers expedient and  
191 proper in the interests of the town. On or before the seventy-fifth day before the annual town  
192 meeting, the board of selectmen shall transmit a copy of the budget, together with its  
193 recommendations relative thereto, to each member of the finance committee.

194 SECTION 17. The town administrator shall perform the duties of the town's director of  
195 municipal finance and, as such, shall be the chief fiscal officer of the town. Warrants for the  
196 payment of town funds prepared by the town accountant in accordance with section 56 of chapter  
197 41 of the General Laws shall be submitted to the town administrator. The approval of warrants  
198 by the town administrator shall be sufficient to authorize payment by the town treasurer, but in  
199 the event of a vacancy in the office of town administrator the selectmen shall approve the  
200 warrants.

201 SECTION 18. Laws, town by-laws, votes, rules, and regulations, whether enacted by the  
202 authority of the town or by any other authority, which are in force in the town of Newbury on the  
203 effective date of this act, or any portion or portions thereof, not inconsistent with this act, shall  
204 continue in full force and effect until otherwise provided by other laws, town by-laws, votes,  
205 rules, and regulations, respectively.

206 SECTION 19. A contract or an action at law or suit in equity, or other proceeding  
207 existing or pending on the effective date of this act shall not be affected by this act.

208 SECTION 20. A person holding a town office or employment under the town shall retain  
209 the office or employment and shall continue to perform the duties of the office or employment  
210 until provisions have been made in accordance with this act for the performance of those duties  
211 by another person or agency. A person who continues in the permanent full-time service or  
212 employment of the town shall not forfeit pay grade or time in service.

213 SECTION 21. This act shall take effect upon its passage.
