An Act relative to safety in child care centers.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Section 1A of chapter 15D of the General Laws, as appearing in the
2 2008 Official Edition, is hereby amended by adding the following new definition:-

3 “Unsafe product”, A children’s product that does not conform to all federal laws and
4 regulations setting forth standards for the children’s product, a children’s product that has been
5 recalled for any reason by a federal agency, the product’s manufacturer, distributor, or importer;
6 the recall has not been rescinded; and the children’s product has been listed by the U.S.
7 Consumer Product Safety Commission created by the consumer product safety act, Public Law
8 92-573, 86 Stat. 1207 (“CPSC”) as a recalled product, or a federal agency has issued a warning
9 that a specific children's product's intended use constitutes a safety hazard and the warning has

10 not been rescinded. A crib is unsafe if it does not conform to the standards endorsed or
11 established by the CPSC.

12 SECTION 2. Chapter 15D of the General Laws, as appearing in the 2008 Official
13 Edition, is hereby amended by adding the following new section:-

14 Child care centers shall be required to certify that no unsafe products are being used or
15 kept on the premises, with the exception that antique or collectible children's products may be
16 kept if they are not used by, or accessible to, a child in the child care facility. An unsafe
17 children's product may be retrofitted if the retrofit has been approved by the federal agency
18 issuing the recall or warning or the federal agency responsible for approving the retrofit if it is
19 different from the federal agency issuing the recall or warning.

20 SECTION 3. Section 2 of Chapter 15D of the General Laws as appearing in the 2008
21 Official Edition is hereby amended by adding at the end thereof the following: -

22 (u) post and maintain a web site that includes an updated list of unsafe child products.
