The Commonwealth of Massachusetts

In the Year Two Thousand Eleven

An Act improving the educational rewards grant program to assist low income workers.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1	SECTION 1. The second sentence of section 2SSS of chapter 29 of the General Laws is
2	hereby amended by inserting the words "public or nonprofit" after the word "accredited".
3	SECTION 2. Section 2SSS of chapter 29 of the General Laws is hereby amended by
4	deleting the words "The grant program shall serve as a last resort, after other federal and state
5	grants have been exhausted" in the second to the last sentence and inserting in lieu thereof the
6	words, "The amount of the award shall be applied towards student financial need in excess of the
7	financial need met by other federal, state or private grants without regard to the amount that may
8	be available through loans".

9 SECTION 3. Notwithstanding any general or special law to the contrary, a portion of the Educational Rewards Grant Program Fund established pursuant to section 2SSS of chapter 29 of 10 the General Laws shall be used for a "Supports for Success" pilot program to assist Educational 11 Rewards recipients complete their degree or certificate programs; provided further, that supports 12 provided through said pilot may include but need not be limited to intensive advising and 13 14 counseling, college and career success courses, work study jobs in the students' field of study, learning communities, curricula redesign to support blended or accelerated remediation, 15 mentoring or tutoring, and child care and transportation assistance. 16

17 SECTION 4. Notwithstanding any general or special law to the contrary, on or before 18 December 1 of each year, the Department of Higher Education in collaboration with the Office 19 of Student Financial Assistance shall submit to the house and senate clerks and the chairs of 20 house and senate committees on ways and means a report on use in the prior fiscal year of the Educational Rewards Grant Program Fund established pursuant to section 2SSS of chapter 29 of 21 the General Laws; provided further, that such report shall include but need not be limited to the 22 number of grants awarded, the amount of each grant, the level of educational attainment of grant 23 recipients before the grant was awarded, degrees and certificates awarded to recipients, recipient 24 demographic information, recipient retention rates while receiving the grant, and analysis of the 25 26 strengths and areas of needed improvement in Educational Rewards Grant Program and the "Supports for Success" pilot program and recommendations for such improvements. 27
