The Commonwealth of Massachusetts

In the Year Two Thousand Thirteen

Resolve to study the financial impact of the nexus between the insurance industry and law enforcement .

1 Resolved,
2 that a special commission is hereby established for the purpose of conducting an
3 investigation and study of the nexus between law enforcement and the insurance industry. The
4 commission shall specifically examine the level of cost savings achieved by the auto insurance
5 industry as a result of the involvement of law enforcement in the following areas: traffic safety
6 and enforcement, accident reconstruction, theft and vandalism, the investigation of insurance
7 fraud, data sharing and administrative support. The commission shall consider the extent of the
8 savings as it pertains to each individual policy holder, policy grouping, or individual insurance
9 company. The commission shall also outline how industry cost savings have been handed down
10 to consumers as a result of the partnership with law enforcement.

11 The commission shall conduct at least 2 public hearings.

12 The commission shall consist of the secretary of public safety and security, who shall
13 serve as chair of the commission; the commissioner of insurance; house and senate chairs of the
14 joint committee on financial services; house and senate chairs of the joint committee on public
15 safety and homeland security; the colonel of state police or his designee; the executive director
16 of the municipal police training committee, the executive director of the merit rating board, a

17 representative from the Massachusetts Chiefs of Police Association, and 3 representatives from
18 the insurance industry as selected by the commissioner of insurance.

19 The commission shall issue a report to the general court with the results of its
20 investigation and study no later than July 1, 2013.
