The Commonwealth of Massachusetts

In the One Hundred and Eighty-Ninth General Court (2015-2016)

An Act relative to the Berkshire County Regional Housing Authority.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 Chapter 495 of the Acts of 2002 is hereby amended, in section 1, by striking out the first
- 2 paragraph and inserting in place thereof the following paragraph:-
- There shall be in Berkshire county, referred to in this act as the county, a public body
- 4 politic and corporate to be known as the Berkshire County Regional Housing Authority, referred
- 5 to in this act as the authority. The authority shall be managed, controlled and governed by a
- 6 board of 7 members of which a simple majority shall constitute a quorum. Two members shall be
- 7 appointed by the Berkshire regional planning commissioner, referred to in this act as the
- 8 commission, with 1 of those members appointed for an initial term of 1 year and 1 of those
- 9 members appointed for an initial term of 3 years. Two members shall be appointed by the mayor
- 10 of the city of Pittsfield, with 1 member appointed for an initial term of 1 year and 1 member
- appointed for an initial term of 2 years. One member shall be appointed by the mayor of the city
- 12 of North Adams with an initial term of 1 year. Two members shall be appointed by the director

of the department of housing and community development, 1 for an initial term of 2 years, and 1 with an initial term of 3 years. Successors shall be appointed in the same manner and by the 14 same appointing entity for terms of 3 years from the expiration of the terms of the original 15 appointees. The mayor of cities or the board of selectmen of towns in the county may nominate 16 17 candidates for the authority and make recommendations to the appointing entities. A vacant seat on the authority shall not remain vacant if there is a qualified person nominated for the seat. The 18 19 authority's membership shall be diverse and represent towns and cities of the county. No more than 2 members of the authority may reside in the same city or town unless no other qualified 20 21 persons have been nominated. Approval of an authority member shall not be withheld unreasonably. 22
