An Act safeguarding the health care decisions of young adults.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 9 SECTION 4. Section 12S of chapter 112 of the General Laws, as so appearing, is hereby
- further amended by striking out, in line 32, the word "parents", and inserting in place thereof the
- 11 following words:- "parent or legal guardian".

- SECTION 5. Section 12S of chapter 112 of the General Laws, as so appearing, is hereby amended by striking out the fourth and fifth sentences.
- SECTION 6. Section 12S of chapter 112 of the General Laws, as so appearing, is hereby further amended by striking out, in line 41, the word "eighteen", and inserting in place thereof the following word:- "sixteen".

  guardians refuse", and inserting in place thereof the following words:- "a parent or guardian

  refuses".
