By Mr. Montigny, a petition (accompanied by bill, Senate, No. 768) of Mark C. Montigny for legislation relative to public charity executive and board directors compensation. The Judiciary.

The Commonwealth of Massachusetts

In the Year Two Thousand Thirteen

An Act Relative to Public Charity Executive and Board of Directors Compensation.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Chapter 180 of the General Laws, as appearing in the 2010 Official Edition, is hereby amended by inserting after section 29 the following sections:-2 3 Section 30. Any public charity with annual gross revenues in excess of \$1,000,000.00 are 4 subject to the following provisions: 5 (a) no officer, director acting in an executive capacity, or senior manager shall receive 6 annual compensation in excess of \$500,000.00; 8 (b) compensation, as defined by this Section, includes salary, bonus payments, incentive 9 payments, deferred compensation, severance payments, below market rate loans, and the lease or rental of any vehicle. 11 Section 31. Board of director or trustees; prohibition against compensation No public charity shall provide compensation as defined in subsection b of Section 30 of 12 this chapter to any member of the board of directors or trustees appointed by a public charity: provided, however, that a member of the board of directors or trustees may receive reimbursement for expenses directly related to the members duties and responsibilities as a 15 16 member of the board. 17 Section 32. Waiver Hearing

Any public charity as defined in Section 30 of this chapter seeking to:

- 19 (a) compensate an officer, director, trustee, or senior manager in excess of the executive compensation cap as defined in Section 30 of this chapter; 20 21 (b) compensate a member of the board of directors or trustees of the public charity; 22 shall be entitled to a public hearing before the a commission comprised of the secretary of the commonwealth, inspector general and attorney general ("Commission"). 23 24 Any public charity seeking said waiver shall comply with the following 25 requirements; 26 (a) request a hearing in writing to the Commission indicating good cause for any 27 deviation from the limits set forth in Section 30 or Section 31; (b) such hearing shall be conducted before the Commission within six months of receipt 28 29 of a written request by a public charity; 30 (c) the board of the public charity shall be responsible for the compensation of an 31 independent auditor. 32 The Auditor of the Commonwealth shall certify the independent auditor's professional 33 competence; certify that the independent auditor has no material financial interest in any entity doing significant business with the public charity; and that the independent auditor has not 35 engaged in any related party transactions within the three years preceding appointment. The 36 Auditor of the Commonwealth shall provide written confirmation to the Commission that these 37 requirements have been satisfied. 38 The independent auditor shall provide a written report to the Commission seven days 39 prior to any hearing conducted pursuant to this Section. 40 The Commission shall review and consider the independent auditor's report at 41 the waiver hearing. The public charity and members of the general public shall be permitted to present additional evidence in support or opposition to such a waiver; all audit documents and 42 any additional evidence submitted at a waiver hearing shall be deemed public records subject to 44 section ten of chapter sixty-six of the general laws. 45 At the close of the waiver hearing, the Commission shall weigh all evidence 46 presented, the charitable purpose of the public charity, and the public interest of the 47 Commonwealth.
- Final determination as to whether a waiver shall be granted shall rest with the Commission who shall make said determination in writing within thirty days of the waiver hearing. Such a waiver shall be granted only if deemed in the public interest of the Commonwealth. If a waiver is granted, it shall be valid only for a period of two years from the date of the decision of Commission

Section 33. Penalties

Any public charity found in violation of Sections 30 or 31 of this chapter, and having failed to obtain a waiver pursuant to Sections 31 of this chapter, shall lose its status as a public charity as it is organized and operates under the general laws.
