The Commonwealth of Massachusetts

In the One Hundred and Ninetieth General Court (2017-2018)

An Act rescinding an order terminating parental rights.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Section 3 of chapter 210 of the General Laws, as appearing in the 2014

2 Official Edition, is hereby amended by adding the following subsection:-

3 (e) For the purposes of this subsection, the term "child" shall include a young adult as 4 defined in section 21 of chapter 119. If at least 2 years have passed since the court entered an 5 order terminating parental rights pursuant to this chapter or chapter 119, a child whose parents 6 were the subject of that order may file a motion requesting that the court vacate the order with 7 respect to 1 or both of the child's former parents, but only if all of the following apply: (i) the 8 child is at least 12 years of age; (ii) the court has determined, after a hearing under section 29B 9 of chapter 119, that adoption is no longer the permanency plan for the child; and (iii) either the 10 child has not been adopted or, if the child has been adopted, a court has entered an order

11 terminating the parental rights of the child's adoptive parents or the adoptive parents have 12 voluntarily surrendered their parental rights. The child shall sign the motion in the absence of a 13 showing of good cause as to why the child is unable to sign the motion. The court shall order 14 that an evidentiary hearing be held and provide notice, in the manner prescribed for a petition 15 filed pursuant to section 24 of chapter 119, of the hearing to the child's former parents. Neither 16 parent shall be considered a party for the purpose of the motion, nor shall either have an 17 independent right to be heard, though a parent's testimony may be offered into evidence if the 18 parent is called as a witness by a party. The court shall grant the motion if it determines by a 19 preponderance of evidence that vacating the order terminating parental rights is in the child's 20 best interests. The court shall specify in writing the factual basis for its determination. As soon 21 as practicable after granting the motion, the court shall enter an order pursuant to subsection (b) 22 of section 26 of chapter 119, provided that the order is in the best interests of the child.

SECTION 2. Section 1 of this act shall apply regardless of whether the two year
requirement is met before, on, or after the effective date of this act.
