CHAPTER _____

1 AN ACT concerning

2 **Historically Black Colleges and Universities – Funding**

3 FOR the purpose of requiring the Maryland Higher Education Commission to establish a
4 certain new unit to assist in evaluating and reviewing certain proposals for new
5 programs and substantial modifications of existing programs by an institution of
6 postsecondary education; requiring the Governor, beginning in a certain fiscal year,
7 to include in the annual budget bill an amount sufficient to employ certain staff;
8 requiring the Governor, in certain fiscal years, to include in the annual budget bill
9 certain funds for certain historically black colleges and universities in the State;
10 specifying how certain funds shall be allocated; providing for the allowable uses of
11 certain funds; providing that certain funds be in addition to certain base funds
12 appropriated to certain institutions; prohibiting certain funds from being included
13 in certain calculations of State funding for certain institutions of higher education
14 under certain provisions of law; requiring certain historically black colleges and
15 universities to report annually, for a certain duration, certain information to the
16 Governor, the President of the Senate, the Speaker of the House, the House
17 Appropriations Committee, and the Senate Budget and Taxation Committee;
18 establishing the Historically Black Colleges and Universities Reserve Fund as a
19 special, nonlapsing fund; specifying the purpose of the Fund; requiring the
20 Commission to administer the Fund; requiring the State Treasurer to hold the Fund
21 and the Comptroller to account for the Fund; specifying the contents of the Fund;
22 specifying the purpose for which the Fund may be used; providing for the investment
23 of money in and expenditures from the Fund; requiring interest earnings of the Fund
24 to be credited to the Fund; exempting the Fund from a certain provision of law

6 academic programs; providing that certain procurements and contracts are not

41 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
42 That the Laws of Maryland read as follows:

Article – Education

10-214.

THE GENERAL ASSEMBLY FINDS THAT:

(1) THE STATE OF MARYLAND WISHES TO PROVIDE ALL OF ITS CITIZENS WITH EQUAL ACCESS TO HIGHER EDUCATION AT EXCELLENT AND AFFORDABLE PUBLIC COLLEGES AND UNIVERSITIES;

(2) THE GENERAL ASSEMBLY HAS CAREFULLY REVIEWED THE MEMORANDUM OPINIONS AND ORDERS OF THE UNITED STATES DISTRICT COURT FOR THE DISTRICT OF MARYLAND, ISSUED OCTOBER 7, 2013, AND NOVEMBER 8, 2017, IN THE ACTION, THE COALITION FOR EQUITY AND EXCELLENCE IN MARYLAND HIGHER EDUCATION, ET AL. V. MARYLAND HIGHER EDUCATION COMMISSION, ET AL., 06-CV-02773-CCB;

(3) THE DISTRICT COURT FOUND THAT THE STATE FAILED TO ELIMINATE A TRACEABLE DE JURE ERA POLICY OF UNNECESSARY DUPLICATION OF PROGRAMS AT HISTORICALLY BLACK COLLEGES AND UNIVERSITIES IN THE STATE THAT HAS EXACERBATED THE RACIAL IDENTIFIABILITY OF MARYLAND’S HISTORICALLY BLACK COLLEGES AND UNIVERSITIES;

(4) MARYLAND’S HISTORICALLY BLACK COLLEGES AND UNIVERSITIES, WHICH ARE BOWIE STATE UNIVERSITY, COPPIN STATE UNIVERSITY, MORGAN STATE UNIVERSITY, AND UNIVERSITY OF MARYLAND EASTERN SHORE, SHOULD RECEIVE ADDITIONAL SUPPORT TO REMEDY THE FINDINGS OF THE DISTRICT COURT;

(5) THE ADDITIONAL SUPPORT SHALL BE PROVIDED IN THE FORM OF ADDITIONAL FUNDING IN THE AMOUNT OF \$577,000,000, WHICH SHALL BE PROVIDED IN AMOUNTS AS CALCULATED UNDER § 15-126 OF THIS ARTICLE IN EACH OF FISCAL YEARS 2023 THROUGH 2032, AND SHALL BE ALLOCATED AMONG THE INSTITUTIONS; AND

(6) THE PROVISIONS OF §§ 15-126 AND 15-127 OF THIS ARTICLE SHALL ENSURE THAT MARYLAND’S HISTORICALLY BLACK COLLEGES AND UNIVERSITIES SHALL RECEIVE THIS SUPPORT.

8 **§§ 11-206 AND 11-206.1 OF THIS SUBTITLE.**

9 **(D) BEGINNING IN FISCAL YEAR 2023, THE GOVERNOR SHALL INCLUDE IN**
10 **THE ANNUAL BUDGET BILL AN APPROPRIATION IN AN AMOUNT SUFFICIENT TO**
11 **EMPLOY THE 10 STAFF MEMBERS REQUIRED UNDER THIS SECTION.**

22 **CALCULATED UNDER PARAGRAPH (2) OF THIS SUBSECTION.**

23 **(2) THE FUNDS PROVIDED UNDER PARAGRAPH (1) OF THIS**
24 **SUBSECTION SHALL BE ALLOCATED TO EACH INSTITUTION IN AN AMOUNT THAT IS**
25 **THE GREATER OF:**

26 **(I) \$9,000,000; OR**

27 **(II) THE PRODUCT OF:**

28 **1. THE PERCENTAGE SHARE OF STUDENTS ENROLLED**
29 **DURING THE IMMEDIATELY PRECEDING ACADEMIC YEAR AT EACH INSTITUTION**

1 COMPARED TO THE TOTAL NUMBER OF STUDENTS ENROLLED AT ALL OF THE
2 HISTORICALLY BLACK COLLEGES AND UNIVERSITIES; AND

3 2. **\$57,700,000.**

4 (3) (I) **FOR FISCAL YEAR 2032, THE GOVERNOR SHALL INCLUDE IN**
5 **THE ANNUAL BUDGET BILL A GENERAL FUND APPROPRIATION EQUAL TO THE**
6 **DIFFERENCE OF:**

7 1. **\$577,000,000; MINUS**

8 2. **THE SUM OF THE TOTAL FUNDS ALLOCATED FOR**
9 **EACH OF FISCAL YEARS 2023 THROUGH 2031 UNDER THIS SECTION.**

10 (II) **THE FUNDS PROVIDED UNDER SUBPARAGRAPH (I) OF THIS**
11 **PARAGRAPH SHALL BE ALLOCATED TO EACH HISTORICALLY BLACK COLLEGE AND**
12 **UNIVERSITY IN AN AMOUNT THAT IS EQUAL TO THE PRODUCT OF:**

13 1. **THE PERCENTAGE SHARE OF STUDENTS ENROLLED**
14 **DURING THE IMMEDIATELY PRECEDING ACADEMIC YEAR AT EACH INSTITUTION**
15 **COMPARED TO THE TOTAL NUMBER OF STUDENTS ENROLLED AT ALL OF THE**
16 **HISTORICALLY BLACK COLLEGES AND UNIVERSITIES; AND**

17 2. **THE AMOUNT OF GENERAL FUNDS DETERMINED FOR**
18 **FISCAL YEAR 2032 UNDER SUBPARAGRAPH (I) OF THIS PARAGRAPH.**

19 (4) **AT THE END OF EACH FISCAL YEAR, ANY UNUSED FUNDS**
20 **PROVIDED UNDER THIS SECTION SHALL BE DISTRIBUTED TO THE HISTORICALLY**
21 **BLACK COLLEGES AND UNIVERSITIES RESERVE FUND ESTABLISHED UNDER §**
22 **15-127 OF THIS SUBTITLE.**

23 (C) **FUNDS PROVIDED UNDER THIS SECTION:**

24 (1) **SHALL BE SUPPLEMENTAL TO, AND MAY NOT SUPPLANT, FUNDS**
25 **APPROPRIATED TO PUBLIC INSTITUTIONS OF HIGHER EDUCATION IN THE STATE**
26 **BUDGET;**

27 (2) **MAY BE USED FOR THE FOLLOWING PURPOSES, AS DETERMINED**
28 **BY THE UNIVERSITY RECEIVING THE FUNDS:**

29 (I) **SCHOLARSHIPS AND FINANCIAL AID SUPPORT SERVICES;**

30 (II) **FACULTY RECRUITMENT AND DEVELOPMENT;**

1 (III) EXPANDING AND IMPROVING EXISTING ACADEMIC
2 PROGRAMS, INCLUDING ONLINE PROGRAMS;

3 (IV) DEVELOPMENT AND IMPLEMENTATION OF NEW ACADEMIC
4 PROGRAMS, INCLUDING ONLINE PROGRAMS;

5 (V) ACADEMIC SUPPORT; AND

6 (VI) MARKETING; AND

7 (3) MAY NOT BE INCLUDED IN THE CALCULATIONS OF STATE
8 FUNDING UNDER §§ 16-305, 16-512, AND 17-104 OF THIS ARTICLE.

9 (D) ON OR BEFORE DECEMBER 1 EACH YEAR, BEGINNING IN 2023 AND
10 GOING THROUGH 2033, EACH HISTORICALLY BLACK COLLEGE OR UNIVERSITY
11 SHALL REPORT TO THE GOVERNOR AND, IN ACCORDANCE WITH § 2-1257 OF THE
12 STATE GOVERNMENT ARTICLE, THE PRESIDENT OF THE SENATE, THE SPEAKER OF
13 THE HOUSE, THE HOUSE APPROPRIATIONS COMMITTEE, AND THE SENATE BUDGET
14 AND TAXATION COMMITTEE ON:

15 (1) THE USES OF THE FUNDS IN ACCORDANCE WITH SUBSECTION
16 (C)(2) OF THIS SECTION; AND

17 (2) ANY NEW ACADEMIC PROGRAM DEVELOPED WITH RESPECT TO:

18 (I) DEVELOPMENT COSTS;

19 (II) STARTUP COSTS; AND

20 (III) ONGOING COSTS TO MAINTAIN THE PROGRAM.

21 15-127.

22 (A) IN THIS SECTION, "FUND" MEANS THE HISTORICALLY BLACK
23 COLLEGES AND UNIVERSITIES RESERVE FUND.

24 (B) THERE IS A HISTORICALLY BLACK COLLEGES AND UNIVERSITIES
25 RESERVE FUND.

26 (C) THE PURPOSE OF THE FUND IS TO PROVIDE RESERVE FUNDING FOR
27 BOWIE STATE UNIVERSITY, COPPIN STATE UNIVERSITY, MORGAN STATE
28 UNIVERSITY, AND UNIVERSITY OF MARYLAND EASTERN SHORE THAT IS USED FOR
29 PURPOSES CONSISTENT WITH THE USES SPECIFIED UNDER § 15-126 OF THIS
30 SUBTITLE.

1 (D) THE MARYLAND HIGHER EDUCATION COMMISSION SHALL
2 ADMINISTER THE FUND.

3 (E) (1) THE FUND IS A SPECIAL, NONLAPSING FUND THAT IS NOT
4 SUBJECT TO § 7-302 OF THE STATE FINANCE AND PROCUREMENT ARTICLE.

5 (2) THE STATE TREASURER SHALL HOLD THE FUND SEPARATELY,
6 AND THE COMPTROLLER SHALL ACCOUNT FOR THE FUND.

7 (F) THE FUND CONSISTS OF:

8 (1) THE REMAINDER OF ANY FUNDS UNUSED AT THE END OF A FISCAL
9 YEAR THAT IS DISTRIBUTED TO THE FUND UNDER § 15-126 OF THIS SUBTITLE;

10 (2) MONEY APPROPRIATED IN THE STATE BUDGET TO THE FUND;

11 (3) INTEREST EARNINGS; AND

12 (4) ANY OTHER MONEY FROM ANY OTHER SOURCE ACCEPTED FOR
13 THE BENEFIT OF THE FUND.

14 (G) THE FUND MAY BE USED ONLY FOR THE USES SPECIFIED UNDER §
15 15-126 OF THIS SUBTITLE.

16 (H) (1) THE STATE TREASURER SHALL INVEST THE MONEY OF THE FUND
17 IN THE SAME MANNER AS OTHER STATE MONEY MAY BE INVESTED.

18 (2) ANY INTEREST EARNINGS OF THE FUND SHALL BE CREDITED TO
19 THE FUND.

20 (I) EXPENDITURES FROM THE FUND MAY BE MADE ONLY IN ACCORDANCE
21 WITH THE STATE BUDGET.

22 (J) MONEY EXPENDED FROM THE FUND FOR THE USES SPECIFIED UNDER §
23 15-126 OF THIS SUBTITLE IS SUPPLEMENTAL TO AND IS NOT INTENDED TO TAKE
24 THE PLACE OF FUNDING THAT OTHERWISE WOULD BE APPROPRIATED FOR THE
25 USES SPECIFIED UNDER § 15-126 OF THIS SUBTITLE OR ANY OTHER FUNDS
26 APPROPRIATED TO PUBLIC INSTITUTIONS OF HIGHER EDUCATION IN THE STATE
27 BUDGET.

28 Article – State Finance and Procurement

29 6-226.

1 (a) (2) (i) Notwithstanding any other provision of law, and unless
2 inconsistent with a federal law, grant agreement, or other federal requirement or with the
3 terms of a gift or settlement agreement, net interest on all State money allocated by the
4 State Treasurer under this section to special funds or accounts, and otherwise entitled to
5 receive interest earnings, as accounted for by the Comptroller, shall accrue to the General
6 Fund of the State.

7 (ii) The provisions of subparagraph (i) of this paragraph do not apply
8 to the following funds:

9 122. the Racing and Community Development Financing Fund;

10 [and]

11 123. the Racing and Community Development Facilities Fund;

12 AND

13 124. THE HISTORICALLY BLACK COLLEGES AND
14 UNIVERSITIES RESERVE FUND.

15 SECTION 2. AND BE IT FURTHER ENACTED, That:

16 (a) (1) The University System of Maryland William E. Kirwan Center for
17 Academic Innovation, in collaboration with UMUC Ventures, shall work with the State's
18 historically black colleges and universities, Bowie State University, Coppin State
19 University, Morgan State University, and University of Maryland Eastern Shore, with the
20 goal of developing and offering online academic programs.

21 (2) The procurements and contracts for developing and offering online
22 academic programs under paragraph (1) of this subsection are not subject to the approval
23 of the Board of Public Works under § 12–112 of the Education Article.

24 (3) The Board of Regents of the University System of Maryland may use
25 the fund balance to support the development and offering of online academic programs
26 under this subsection.

27 (b) On or before December 1, 2021, each institution shall submit a report on its
28 efforts and any findings to the Governor and, in accordance with § 2–1257 of the State
29 Government Article, the President of the Senate and the Speaker of the House that
30 summarizes the steps taken to comply with the requirement provided under subsection (a)
31 of this section.

32 SECTION 3. AND BE IT FURTHER ENACTED, That:

33 (a) The Maryland Higher Education Commission shall, in consultation with
34 Morgan State University, the University System of Maryland, and St. Mary's College of
35 Maryland, study the Commission's current policies and practices and any new policies or

1 practices established in accordance with this Act for the purpose of:

2 (1) evaluating, streamlining, improving, and making recommendations on
3 the Commission's policies and practices with respect to academic program review;

4 (2) enhancing the economic competitiveness of the State by ensuring the
5 responsiveness of institutions of higher education to market demand; and

6 (3) effectively supporting the State's workforce development requirements.

7 (b) On or before December 1, 2021, the Commission shall submit a report on its
8 findings to the Governor and, in accordance with § 2–1257 of the State Government Article,
9 the President of the Senate and the Speaker of the House that summarizes the results of
10 the study conducted in accordance with subsection (a) of this section.

11 SECTION 4. AND BE IT FURTHER ENACTED, That:

12 (a) The State's historically black colleges and universities, Bowie State
13 University, Coppin State University, Morgan State University, and University of Maryland
14 Eastern Shore, are encouraged to hire a consultant who would assist the institutions, as a
15 collective, with programmatic development.

16 (b) On or before December 1, 2021, each institution shall submit a report on its
17 efforts and any findings to the Governor and, in accordance with § 2–1257 of the State
18 Government Article, the President of the Senate and the Speaker of the House that
19 summarizes the steps taken to comply with subsection (a) of this section.

20 SECTION 5. AND BE IT FURTHER ENACTED, That the State's historically black
21 colleges and universities, Bowie State University, Coppin State University, Morgan State
22 University, and University of Maryland Eastern Shore, are encouraged to use funds
23 provided by this Act to support and implement the Blueprint for Maryland's Future.

24 SECTION 6. AND BE IT FURTHER ENACTED, That:

25 (a) Section 1 of this Act is contingent on the execution of a final settlement
26 agreement in the case of The Coalition for Equity and Excellence in Maryland Higher
27 Education v. Maryland Higher Education Commission, 06–CV–02773–CCB (D. MD) on or
28 before June 1, 2021, that:

29 (1) incorporates and does not exceed the financial and programmatic
30 commitments contained in Section 1 of this Act;

31 (2) incorporates the order described in subsection (d)(2) of this section; and

32 (3) provides for attorney's fees and expenses in an amount not less than
33 \$14,000,000 but not more than \$25,000,000 to plaintiffs' counsel in The Coalition for Equity
34 and Excellence in Maryland Higher Education v. Maryland Higher Education Commission,

1 06–CV–02773–CCB (D. MD).

2 (b) (1) In fiscal year 2023, the Governor shall provide an allocation for the
3 attorney’s fees and expenses in the amount specified in the final settlement agreement
4 described in subsection (a) of this section.

5 (2) The amount allocated under paragraph (1) of this subsection shall be
6 provided from the funds for the historically black colleges and universities under Section 1
7 of this Act, with the amounts allocated based on each institution’s share of the total funds
8 provided under Section 1 of this Act.

9 (3) Notwithstanding § 12–501 of the State Government Article or any other
10 provision of law, the settlement agreement as provided in subsection (a) of this section,
11 including attorney’s fees and expenses provided in the settlement agreement, are not
12 subject to approval by the Board of Public Works.

13 (c) The Attorney General:

14 (1) is authorized to execute the final settlement agreement in subsection
15 (a) of this section on behalf of the State on terms the Attorney General deems:

16 (i) as final resolution of the case of The Coalition for Equity and
17 Excellence in Maryland Higher Education v. the Maryland Higher Education Commission,
18 06–CV–02773–CCB (D. MD); and

19 (ii) appropriate to carry out the purposes of Section 1 of this Act; and

20 (2) shall provide written notice of the executed settlement agreement to the
21 Department of Legislative Services, 90 State Circle, Annapolis, MD 21401.

22 (d) Section 1 of this Act, with no further action required by the General Assembly,
23 shall be null and void if, on or before June 11, 2021:

24 (1) the Department of Legislative Services has not received notice of the
25 settlement agreement; and

26 (2) an order has not been issued from the United States District Court for
27 the District of Maryland or the United States Court of Appeals for the Fourth Circuit that:

28 (i) reverses or vacates the District Court’s holding that the State
29 failed to eliminate traceable de jure era policy of unnecessary program duplication; or

30 (ii) holds that any policy of unnecessary program duplication
31 traceable to de jure segregation has been cured by the terms of the settlement agreement.

32 SECTION 7. AND BE IT FURTHER ENACTED, That, except as provided in Section
33 6 of this Act, this Act is an emergency measure, is necessary for the immediate preservation

1 of the public health or safety, has been passed by a yea and nay vote supported by
2 three-fifths of all the members elected to each of the two Houses of the General Assembly,
3 and shall take effect from the date it is enacted.
