

Education – Child Abuse and Sexual Misconduct Prevention – Hiring Emergent Employees

4 FOR the purpose of authorizing the hiring of a certain emergent employee by a county 5 board of education or nonpublic school for a certain period of time under certain 6 conditions; authorizing a county board or nonpublic school to take certain actions 7 within a certain period of time regarding an emergent employee under certain 8 circumstances; authorizing a certain appeal following a certain decision by a county 9 board; prohibiting a certain decision by a county board from being subject to a certain collective bargaining process; authorizing a county board to share a certain 10 11 employment history review with other county boards; authorizing a county board to 12 use a certain employment history review under certain circumstances; requiring 13 certain applicants to provide certain information regarding certain employers over a 14 certain period of time; defining a certain term; altering a certain definition; and generally relating to child abuse and sexual misconduct prevention and the hiring of 15 16 school employees.

- 22 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
- 23 That the Laws of Maryland read as follows:

- 26 (a) (1) In this section the following words have the meanings indicated.

25	(i) The dates of employment of the applicant; and		
26 27	(ii) Answers to the questions regarding child sexual abuse or sexual misconduct required under subsection (b)(3) of this section; and		
28 29	(2) Request a report from the Department regarding the applicant's eligibility for employment or certification status to determine whether the applicant:		
30 31	(i) Holds a valid and active certification appropriate for the position and is otherwise eligible for employment; and

- 1 (ii) Has been the subject of professional discipline related to child 2 sexual abuse or sexual misconduct.
- 3 (d) (1) Not later than 20 days after receiving a request for information under 4 subsection (c) of this section, an employer shall send to the county board, nonpublic school, 5 or contracting agency the information requested on the form prescribed by the Department.
 - (2) If the information from an employer includes an affirmative response to the child sexual abuse or sexual misconduct questions under subsection (b)(3) of this section, and the county board, nonpublic school, or contracting agency makes a determination to further consider the applicant for employment, the county board, nonpublic school, or contracting agency shall request that the former employer provide additional information about the information provided, including all records related to child sexual abuse or sexual misconduct.
- 13 (3) An employer that receives a request for additional information under 14 paragraph (1) of this subsection shall provide the additional information within 60 days of 15 the date of the prospective employer's request to:
- 16 (i) The requesting county board, nonpublic school, or contracting 17 agency; and

- 19 **(E) (1) A** COUNTY BOARD OR NONPUBLIC SCHOOL MAY HIRE AN 20 APPLICANT AS AN EMERGENT EMPLOYEE FOR A PERIOD NOT TO EXCEED **60** DAYS 21 PENDING THE REVIEW OF INFORMATION AND RECORDS REQUIRED UNDER THIS 22 SECTION ONLY IF:
- 23 (I) THE APPLICANT HAS PROVIDED ALL THE INFORMATION 24 AND SUPPORTING DOCUMENTATION REQUIRED UNDER THIS SECTION;
- 25 (II) AN EMPLOYER HAS NO KNOWLEDGE OF INFORMATION 26 REGARDING THE APPLICANT THAT WOULD DISQUALIFY THE APPLICANT FROM 27 EMPLOYMENT;
- 28 (III) THE APPLICANT SWEARS OR AFFIRMS THAT THE APPLICANT 29 IS NOT DISQUALIFIED FROM EMPLOYMENT; AND

- 1 (ii) An employment history review of a substitute employee shall 2 remain valid as long as the substitute employee continues to be employed by the same 3 county board or remains on the approved substitute employee list of the nonpublic school 4 or contracting agency.
- 5 (2) If a substitute employee is seeking to be added to the substitute 6 employee list of another county board, nonpublic school, or contracting agency, a new 7 employment history review in accordance with subsection (c) of this section is required.
- 8 (3) The appearance of a substitute employee on the substitute employee 9 list of one county board, nonpublic school, or contracting agency does not relieve another 10 county board, nonpublic school, or contracting agency of the duty of compliance with this section.
- 12 (4) An employment history review conducted on the initial hiring of a 13 substitute employee by a contracting agency, an intermediate unit, or any other entity that 14 provides substitute staffing services to a county board or a nonpublic school shall satisfy 15 the requirements of this section for all school entities using the services of that contracting 16 agency, intermediate unit, or other entity.
- 17 (5) A contracting agency, an intermediate unit, or any other entity providing substitute staffing services to a school entity shall comply with the provisions of this section.
- [(f)] (I) (i) A contracting agency shall conduct an employment history review of an applicant for employment with the contracting agency as required under subsection (c) of this section:
- 23 1. At the time of the initial hiring of the employee; or
- 24 2. Before the employee is assigned to work for a school entity 25 in a position involving direct contact with minors.
- 26 (ii) The employment history review under subparagraph (i) of this 27 paragraph shall remain valid as long as the employee continues to be employed by the 28 hiring contracting agency.
 - (iii) A contracting agency shall:
- 30 1. Maintain a record of each employee's employment history 31 review required under this subsection; and
- 32 2. On request of the school entity to which an employee is assigned, provide access to the contracting agency's records of that employee.
- 34 (2) (i) Before assigning an employee to perform work for a school entity 35 in a position involving direct contact with minors, a contracting agency shall provide notice

- to the school entity of any affirmative responses to the child sexual abuse or sexual misconduct questions required under subsection (b)(3) of this section.
- 3 (ii) A contracting agency may not assign an employee to perform 4 work for a school entity in a position involving direct contact with minors if the school entity 5 objects to the assignment after receiving the notice required under subparagraph (i) of this 6 paragraph.
- [(g)] (J) (1) Information and records about an applicant received by a county board, nonpublic school, or contracting agency under this section are not a public record for the purposes of the Maryland Public Information Act.
- 10 (2) A county board, nonpublic school, or contracting agency that receives 11 information and records from an employer about an applicant under this section may:
- 12 (i) Use the information and records for the purpose of evaluating the applicant's fitness to be hired or for continued employment; and
- 14 (ii) Report the information to the Department, a State licensing 15 agency, a law enforcement agency, a child protective services agency, another school entity, 16 or any other prospective employer, as appropriate.
- [(h)] (K) (1) A county board, nonpublic school, or contracting agency may not enter into a collective bargaining agreement, an employment contract, an agreement for resignation or termination, a severance agreement, or any other contract or agreement that:
- 21 (i) Has the effect of suppressing information relating to an 22 investigation or disciplinary action in response to a report of suspected child sexual abuse 23 or sexual misconduct by a current or former employee;
- 24 (ii) Affects the ability of the county board, nonpublic school, or 25 contracting agency to report suspected child sexual abuse or sexual misconduct to the 26 appropriate authorities; or
- (iii) Requires the county board, nonpublic school, or contracting agency to expunge information about allegations or findings of suspected child sexual abuse or sexual misconduct from any document maintained by the employer unless the investigation resulted in a finding by:
- 1. The employer that allegations that the applicant engaged in sexual misconduct lacked sufficient evidence according to the policies of the county board or nonpublic school;
