13 14 15	(a) A dental hygienist may monitor a patient to whom nitrous oxide is administered provided the monitoring of the patient is under the supervision of a dentist who is physically present on the premises.
16 17	(b) Before a dental hygienist may monitor a patient to whom nitrous oxide is administered, the dental hygienist shall successfully complete the following:
18	(1) Any educational requirements established by the Board; and
19	(2) A written and clinical examination as required by the Board.
20 21 22	(c) A dental hygienist shall complete the educational requirements established by the Board under subsection (b)(1) of this section through an accredited dental hygiene program.
