BY repealing and reenacting, with amendments, Article – General Provisions Section 1–301 Annotated Code of Maryland (2019 Replacement Volume and 2020 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: **Article - General Provisions** 1 - 301. The standard time in the State shall be [that of the 75th meridian of longitude west from Greenwich EASTERN DAYLIGHT TIME YEAR-ROUND. The standard time described under subsection (a) of this section shall regulate all courts, banking institutions, public offices, and legal or official proceedings.

1 SECTION 2. AND BE IT FURTHER ENACTED, That:

- 2 (a) (1) In this section the following words have the meanings indicated.
- 3 (2) "Coordinated Universal Time" means the time scale maintained 4 through the General Conference of Weights and Measures and interpreted or modified for 5 the United States by the Secretary of Commerce in coordination with the Secretary of the
- 6 Navy.
- 7 (3) "Eastern Daylight Time" means Coordinated Universal Time minus 4 8 hours.
- 9 (4) "Eastern time zone" means the geographic area established as the 10 "second zone" under federal law with a standard time of Coordinated Universal Time minus 11 5 hours.
- 12 (b) Section 1 of this Act is contingent on:
- 13 (1) enacting of a similar act by all of the states, including the District of
 14 Columbia, whose geographic boundaries are completely within the eastern time zone
 15 Delaware, the District of Columbia, Pennsylvania, Virginia, and West Virginia; and
- 16 (2) 15 U.S.C. § 260a being amended to allow the states or a state, individually, to observe a year–round standard time that is consistent with Eastern Daylight Time.
- 19 (c) (1) The Secretary of State shall monitor:
- 20 (i) which states have enacted an act that is similar to this Act; and
- 21 (ii) action by the federal government to determine whether the 22 change to 15 U.S.C. § 260a described under item (b)(2) of this section is made.
- 23 (2) If the Secretary of State determines that all of the necessary states have 24 enacted a similar act to this Act and the federal government has made the change to 15 25 U.S.C. § 260a in accordance with this section, the Secretary of State shall notify the 26 Department of Legislative Services within 5 days after the determination is made.
- 27 (d) If the Department of Legislative Services receives the notice described in subsection (c)(2) of this section on or before December 31, 2026, Section 1 of this Act shall take effect on the earlier of the second Sunday of March or the first Sunday of November 30 after the following have occurred:
- 31 (1) all of the necessary states have enacted a similar act to this Act; and
- 32 (2) the change to 15 U.S.C. § 260a becomes effective.
