## A BILL ENTITLED

1 AN ACT concerning

2 **Motor Vehicle Liability Insurance – Information from Applicant**

3 FOR the purpose of prohibiting an insurer or insurance producer from asking an  
4 applicant for private passenger motor vehicle liability insurance about certain  
5 information that is not directly related to certain criteria; providing for the  
6 application of this Act; providing for a delayed effective date; and generally  
7 relating to private passenger motor vehicle liability insurance.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
14 MARYLAND, That the Laws of Maryland read as follows:

15 **Article – Insurance**

16 **19–504.2.**

17 **IN CONNECTION WITH AN APPLICATION FOR THE ISSUANCE OR RENEWAL**  
18 **OF A POLICY OF PRIVATE PASSENGER MOTOR VEHICLE LIABILITY INSURANCE,**  
19 **AN INSURER OR INSURANCE PRODUCER MAY NOT ASK THE APPLICANT FOR**  
20 **INFORMATION THAT IS NOT DIRECTLY RELATED TO:**

21 **(1) THE IDENTITY AND ADDRESSES OF EACH INSURED AND**  
22 **COVERED DRIVER;**

1                   **(2) THE REGISTRATION INFORMATION FOR EACH COVERED**  
2 **VEHICLE;**

3                   **(3) INFORMATION RELATING TO THE CONDITION OF EACH**  
4 **COVERED VEHICLE;**

5                   **(4) THE DRIVING HABITS OF EACH INSURED AND COVERED**  
6 **DRIVER;**

7                   **(5) THE DRIVING PATTERNS APPLICABLE TO EACH COVERED**  
8 **VEHICLE; AND**

9                   **(6) THE ABILITY OF THE FIRST NAMED INSURED OR OTHER**  
10 **RESPONSIBLE PARTY TO PAY FOR THE POLICY.**

11           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall apply to all  
12 private passenger motor vehicle liability insurance policies issued, delivered, or  
13 renewed in the State on or after the effective date of this Act.

14           SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect  
15 January 1, 2012.
