- 25**(B)** A TEMPORARY LICENSE ISSUED UNDER THIS SECTION AUTHORIZES THE 26 HOLDER TO PRACTICE SOCIAL WORK IN THE STATE ONLY UNDER THE SUPERVISION OF A BOARD-APPROVED SUPERVISOR WHILE THE TEMPORARY LICENSE IS 27 28 EFFECTIVE.

- 1 (C) A TEMPORARY LICENSE IS VALID UNTIL 180 DAYS AFTER THE 2 EXAMINATION BECOMES READILY AVAILABLE TO THE APPLICANT.

- (a) Unless the Board agrees to accept the surrender of a license, a licensed social worker **OR THE HOLDER OF A TEMPORARY LICENSE** may not surrender the license nor may the license lapse by operation of law while the licensee is under investigation or while charges are pending against the social worker.
- 8 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 9 October 1, 2023.
