State Board of Examiners of Nursing Home Administrators – Renaming and,
 Licensure of Assisted Living Managers, and Penalties

FOR the purpose of renaming the State Board of Examiners of Nursing Home 4 5 Administrators to be the State Board of Long-Term Care Administrators and 6 establishing a licensing and regulatory system for assisted living managers under 7 the Board; requiring the Office of Health Care Quality, beginning on a certain date, 8 to notify the Board of the appointment of an assisted living program as a resident's representative payee; establishing a civil penalty for taking certain actions related 9 10 to practicing as a nursing home administrator or an assisted living manager without a license; and generally relating to the licensing of assisted living managers and the 11 12 State Board of Long-Term Care Administrators.
