A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Medical Assistance Program – Maternal Fetal Medicine Services –**
3 **Reimbursement**

4 FOR the purpose of requiring the Maryland Medical Assistance Program to reimburse
5 physicians billing for maternal fetal medicine services using certain codes at the rate
6 associated with the codes under the federal Medicare fee schedule; and generally
7 relating to maternal fetal medicine services.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
14 That the Laws of Maryland read as follows:

15 **Article – Health – General**

16 **15–112.1.**

17 **(A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS**
18 **INDICATED.**

19 **(2) (I) “MATERNAL FETAL MEDICINE CODE” MEANS THE CURRENT**
20 **PROCEDURAL TERMINOLOGY CODE ASSOCIATED WITH A MATERNAL FETAL**
21 **MEDICINE SERVICE.**

22 **(II) “MATERNAL FETAL MEDICINE CODE” INCLUDES THE**
23 **FOLLOWING CURRENT PROCEDURAL TERMINOLOGY CODES:**

5 **(3) (I) “MATERNAL FETAL MEDICINE SERVICE” MEANS A SERVICE**
6 **PROVIDED BY A SPECIALIZED PHYSICIAN FOR THE TREATMENT OF A PATIENT WHO**
7 **HAS A PREGNANCY THAT IS CONSIDERED HIGH-RISK.**

8 **(II) “MATERNAL FETAL MEDICINE SERVICE” INCLUDES THE**
9 **SERVICE PROVIDED FOR THE TREATMENT OF A PREGNANT PATIENT WITH:**

- 10 1. **DIABETES;**
- 11 2. **HYPERTENSION;**
- 12 3. **MULTIPLE GESTATION;**
- 13 4. **RECURRENT MISCARRIAGE; OR**
- 14 5. **A FAMILY HISTORY OF GENETIC DISEASE.**

15 **(B) THE PROGRAM SHALL REIMBURSE PHYSICIANS BILLING FOR A**
16 **MATERNAL FETAL MEDICINE CODE AT THE RATE ASSOCIATED WITH THE CODE**
17 **UNDER THE FEDERAL MEDICARE FEE SCHEDULE.**

18 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
19 October 1, 2024.
