## A BILL ENTITLED

1 AN ACT concerning

2 **Primary and Secondary Education – Online Courses and Services –**  
3 **Accessibility**

4 FOR the purpose of requiring the development, review, and approval of certain online  
5 courses and services to include an assessment regarding the accessibility of the  
6 online course or service to certain individuals with disabilities; authorizing the  
7 State Department of Education or a county board of education to contract with a  
8 third party for the development of a certain assessment or a certain method by  
9 which certain online courses or services will be made available to certain  
10 individuals; authorizing the State Board of Education to set certain fees for the  
11 development of a certain assessment and a certain method; and generally  
12 relating to the accessibility of online courses and services to individuals with  
13 disabilities, including the blind.

6 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
7 MARYLAND, That the Laws of Maryland read as follows:

8 **Article – Education**

9 7–1002.

10 (b) **(3) (I) THE DEVELOPMENT, REVIEW, AND APPROVAL OF AN**  
11 **ONLINE COURSE OR SERVICE CONDUCTED UNDER THIS SUBSECTION SHALL**  
12 **INCLUDE AN ASSESSMENT REGARDING THE ACCESSIBILITY OF THE ONLINE**  
13 **COURSE OR SERVICE TO INDIVIDUALS WITH DISABILITIES, INCLUDING THE**  
14 **BLIND.**

15 **(II) THE DEPARTMENT OR A COUNTY BOARD MAY**  
16 **CONTRACT WITH A THIRD PARTY FOR:**

17 **1. THE DEVELOPMENT OF THE ASSESSMENT**  
18 **REGARDING ACCESSIBILITY REQUIRED UNDER SUBPARAGRAPH (I) OF THIS**  
19 **PARAGRAPH; OR**

20 **2. IF THE ASSESSMENT DETERMINES THAT THE**  
21 **ONLINE COURSE OR SERVICE IS NOT ACCESSIBLE TO INDIVIDUALS WITH**  
22 **DISABILITIES, INCLUDING THE BLIND, THE DEVELOPMENT OF A METHOD BY**  
23 **WHICH THE ONLINE COURSE OR SERVICE WILL BE MADE ACCESSIBLE TO**  
24 **INDIVIDUALS WITH DISABILITIES, INCLUDING THE BLIND.**

25 (c) (1) There is a Maryland Virtual Learning Opportunities Fund.

26 (2) The State Board may set reasonable fees for:

27 (i) Developing or reviewing online courses and services; [and]

28 (ii) Processing approvals for online courses and services;

29 **(III) DEVELOPING AN ASSESSMENT REGARDING THE**  
30 **ACCESSIBILITY OF AN ONLINE COURSE OR SERVICE TO INDIVIDUALS WITH**  
31 **DISABILITIES, INCLUDING THE BLIND; AND**

1                           **(IV) DEVELOPING A METHOD BY WHICH AN ONLINE COURSE**  
2 **OR SERVICE WILL BE MADE ACCESSIBLE TO INDIVIDUALS WITH DISABILITIES,**  
3 **INCLUDING THE BLIND.**

4                   SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
5 October 1, 2013.
