A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2009 – Washington County –**
3 **Doleman Black Heritage Museum**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2009
5 to extend the deadline for the Board of Directors of the Doleman Black Heritage
6 Museum, Inc. to present evidence that a matching fund will be provided;
7 requiring that the Board of Public Works expend or encumber the proceeds of
8 the loan by June 1, 2013; and generally relating to amending the Maryland
9 Consolidated Capital Bond Loan of 2009.

10 BY repealing and reenacting, with amendments,
11 Chapter 485 of the Acts of the General Assembly of 2009
12 Section 1(3) Item ZA03(BP)

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
14 MARYLAND, That the Laws of Maryland read as follows:

19 (BP) Doleman Black Heritage Museum. Provide a grant equal to
20 the lesser of (i) \$25,000 or (ii) the amount of the matching
21 fund provided, to the Board of Directors of the Doleman Black
22 Heritage Museum, Inc. for the acquisition, planning, and
23 design of the Doleman Black Heritage Museum, located in
24 Hagerstown. **NOTWITHSTANDING SECTION 1(5) OF THIS**
25 **ACT, THE GRANTEE HAS UNTIL JUNE 1, 2013, TO**

1 **PRESENT EVIDENCE THAT A MATCHING FUND WILL BE**
 2 **PROVIDED. NOTWITHSTANDING SECTION 1(7) OF THIS**
 3 **ACT, THE PROCEEDS OF THE LOAN MUST BE EXPENDED**
 4 **OR ENCUMBERED BY THE BOARD OF PUBLIC WORKS FOR**
 5 **THE PURPOSES PROVIDED IN THIS ACT NO LATER THAN**
 6 **JUNE 1, 2013** (Washington County) 25,000

7 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
 8 June 1, 2011.
