### 2 Anne Arundel County Board of Education – Human Trafficking Awareness Pilot 3 Program

- 4 FOR the purpose of establishing the Human Trafficking Awareness Pilot Program in Anne 5 Arundel County; providing for the duration of the Program; requiring the Anne 6 Arundel County Board of Education, in collaboration with the Department of Health 7 and Mental Hygiene and the Governor's Office of Crime Control and Prevention, to 8 provide awareness and training for all school-based personnel on human trafficking; 9 requiring the Department and the Governor's Office of Crime Control and Prevention 10 to provide <del>certain resource information and</del> certain materials to the Board; <del>requiring</del> the Board to report on or before a certain date each year to certain committees of the 11 General Assembly; providing for the application of this Act; providing for the 12 termination of this Act; and generally relating to the Human Trafficking Awareness 13 Pilot Program and the Anne Arundel County Board of Education. 14

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

21 That the Laws of Maryland read as follows:

#### 1 Article – Education

- 3 (A) THIS SECTION APPLIES ONLY IN ANNE ARUNDEL COUNTY.
- 4 (B) (1) THERE IS A HUMAN TRAFFICKING AWARENESS PILOT PROGRAM.
- 5 (2) THE PILOT PROGRAM SHALL BEGIN IN THE 2017–2018 SCHOOL 6 YEAR AND LAST FOR 2 YEARS.
- 7 (C) THE ANNE ARUNDEL COUNTY BOARD OF EDUCATION, IN 8 COLLABORATION WITH THE DEPARTMENT OF HEALTH AND MENTAL HYGIENE AND 9 THE GOVERNOR'S OFFICE OF CRIME CONTROL AND PREVENTION, SHALL PROVIDE AWARENESS AND TRAINING FOR ALL SCHOOL—BASED PERSONNEL ON HUMAN 11 TRAFFICKING.
- 12 (D) THE DEPARTMENT OF HEALTH AND MENTAL HYGIENE AND THE 13 GOVERNOR'S OFFICE OF CRIME CONTROL AND PREVENTION SHALL PROVIDE TO 14 THE BOARD:
- 15 **(1)** RESOURCE INFORMATION ON HUMAN TRAFFICKING; AND
- 16 (2) MATERIALS MATERIALS FOR DISTRIBUTION THAT DESCRIBE
  17 LOCAL, STATE, AND NATIONAL RESOURCES TO WHICH SCHOOL-BASED PERSONNEL
  18 CAN REFER FOR INFORMATION ON HUMAN TRAFFICKING.
- 19 (E) ON OR BEFORE JULY 1 EACH YEAR, THE ANNE ARUNDEL COUNTY
  20 BOARD OF EDUCATION SHALL REPORT TO THE SENATE EDUCATION, HEALTH, AND
  21 ENVIRONMENTAL AFFAIRS COMMITTEE AND THE HOUSE COMMITTEE ON WAYS
  22 AND MEANS, IN ACCORDANCE WITH § 2–1246 OF THE STATE GOVERNMENT
  23 ARTICLE, ON THE EFFECTIVENESS OF THE HUMAN TRAFFICKING AWARENESS
  24 PHOT PROGRAM.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2016. It shall remain effective for a period 3 years and, at the end of June 30, 2019, with no further action required by the General Assembly, this Act shall be abrogated and of no further force and effect.
