Wicomico County - Board of Education - Selection of Members - Straw Ballot

FOR the purpose of requiring that a question certain questions be placed on the ballot in Wicomico County at the November general election of 2012 to determine the sense of the voters of the County on the issue of changing whether to change the method of selecting members of the Wicomico County Board of Education; providing for carrying out of the straw ballot; and generally relating to the holding of a straw ballot in Wicomico County.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That under the provisions of the Election Law Article, the Wicomico County Board of Elections, in consultation with the State Board of Elections, shall prepare and include on the ballot for the November general election of 2012 the following question questions:

"Wicomico County Board of Education – Election of Members

<u>"Do Do you favor changing the method of selection of the members of the Wicomico County Board of Education from appointment by the Governor to a nonpartisan election of a member from each council district and of some of the members from the county at—large by the voters of Wicomico County?"</u>

"Wicomico County Board of Education - Appointed Members
