## A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Commission on Health Equity – Membership and Statewide Health**  
3 **Equity Plan**

4 FOR the purpose of requiring the Maryland Commission on Health Equity to develop and  
5 monitor a certain statewide health equity plan; requiring the Maryland Commission  
6 on Health Equity to coordinate with the Maryland Department of Health and the  
7 Health Services Cost Review Commission when establishing a certain advisory  
8 committee; and generally relating to the Maryland Commission on Health Equity.

19 Preamble

20 WHEREAS, The next phase of Maryland’s unique Total Cost of Care Model will  
21 require the State to designate a governance structure to develop and implement a statewide  
22 health equity plan; and

23 WHEREAS, The governance structure must be designated and begin its work on the  
24 development of the statewide health equity plan before the 2025 legislative session; and

1 WHEREAS, The governance structure must meet specific federal requirements  
2 regarding membership and duties; and

3 WHEREAS, The Maryland Commission on Health Equity is positioned to serve as  
4 the governance structure for the statewide health equity plan required under the next  
5 phase of the Total Cost of Care Model; now, therefore,

6 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
7 That the Laws of Maryland read as follows:

8 **Article – Health – General**

- 10 (a) In this subtitle the following words have the meanings indicated.
- 11 (b) “Commission” means the Maryland Commission on Health Equity.
- 12 (c) “Health equity framework” means a public health framework through which  
13 policymakers and stakeholders in the public and private sectors use a collaborative  
14 approach to improve health outcomes and reduce health inequities in the State by  
15 incorporating health considerations into decision making across sectors and policy areas.

16 **(D) “STATEWIDE HEALTH EQUITY PLAN” MEANS THE EQUITY PLAN**  
17 **REQUIRED UNDER A COOPERATIVE GRANT FUNDING AGREEMENT WITH THE**  
18 **CENTER FOR MEDICARE AND MEDICAID INNOVATION.**

10 the Maryland Association of County Health Officers; AND

11            **(19) THE FOLLOWING MEMBERS, APPOINTED BY THE SECRETARY**  
12 **WITH THE ADVICE OF THE HEALTH SERVICES COST REVIEW COMMISSION:**

13            **(I) AT LEAST ONE REPRESENTATIVE OF HOSPITALS IN THE**  
14 **STATE;**

15            **(II) AT LEAST TWO INDIVIDUALS WITH EXPERIENCE IN**  
16 **HOSPITAL-BASED POPULATION HEALTH;**

17            **(III) AT LEAST ONE REPRESENTATIVE OF A FEDERALLY**  
18 **QUALIFIED HEALTH CENTER IN THE STATE;**

19            **(IV) AT LEAST TWO REPRESENTATIVES OF COMMUNITY-BASED**  
20 **ORGANIZATIONS;**

21            **(V) AT LEAST TWO PATIENTS FROM UNDERSERVED**  
22 **COMMUNITIES;**

23            **(VI) AT LEAST ONE REPRESENTATIVE OF A MANAGED CARE**  
24 **ORGANIZATION;**

25            **(VII) AT LEAST ONE REPRESENTATIVE OF A COMMERCIAL**  
26 **HEALTH INSURER;**

27            **(VIII) AT LEAST TWO REPRESENTATIVES OF CLINICIANS AND**  
28 **PROVIDERS WHO ARE NOT AFFILIATED WITH A HOSPITAL OR A FEDERALLY**  
29 **QUALIFIED HEALTH CENTER;**

1                   **(IX) AT LEAST ONE REPRESENTATIVE FROM THE STATE RURAL**  
2 **HEALTH OFFICE; AND**

3                   **(X) AT LEAST ONE REPRESENTATIVE OF A TRIBAL COMMUNITY**  
4 **IN THE STATE.**

5           (b) To the extent practicable, the members appointed to the Commission shall  
6 reflect the geographic, racial, ethnic, cultural, and gender diversity of the State.

7           (c) A majority of the members present at a meeting shall constitute a quorum.

8           (d) (1) Subject to paragraph (2) of this subsection, the Commission shall  
9 determine the times, places, and frequency of its meetings.

10                   (2) The Commission shall meet at least four times each year.

12           [(a) The Governor shall designate the chair of the Commission from among the  
13 members of the Commission.]

14           **(A) THE SECRETARY, OR THE SECRETARY'S DESIGNEE, AND THE**  
15 **EXECUTIVE DIRECTOR OF THE HEALTH SERVICES COST REVIEW COMMISSION, OR**  
16 **THE EXECUTIVE DIRECTOR'S DESIGNEE, SHALL COCHAIR THE COMMISSION.**

17           (b) A member of the Commission:

18                   (1) May not receive compensation as a member of the Commission; but

19                   (2) Is entitled to reimbursement for expenses under the Standard State  
20 Travel Regulations, as provided in the State budget.

21           (c) The Department shall provide staff support for the Commission.

23           (a) The purpose of the Commission is to:

24                   (1) Employ a health equity framework to [examine]:

25                           **(I) DEVELOP A STATEWIDE HEALTH EQUITY PLAN; AND**

26                           **(II) EXAMINE:**

27                                   **[(i)] 1.** The health of residents of the State to the extent necessary  
28 to carry out the requirements of this section;

1                    [(ii)] 2. Ways for units of State and local government to  
 2 collaborate to implement policies that will positively impact the health of residents of the  
 3 State; and

4                    [(iii)] 3. The impact of the following factors on the health of  
 5 residents of the State:

6                    [1.] A. Access to safe and affordable housing;

7                    [2.] B. Educational attainment;

8                    [3.] C. Opportunities for employment;

9                    [4.] D. Economic stability;

10                   [5.] E. Inclusion, diversity, and equity in the workplace;

11                   6. Barriers to career success and promotion in the workplace;

12                   7. Access to transportation and mobility;

13                   8. Social justice;]

14                   [9.] E. Environmental factors;

15                   [10.] F. Public safety, including the impact of crime, citizen  
 16 unrest, the criminal justice system, and governmental policies that affect individuals who  
 17 are in prison or released from prison; and

18                   [11.] G. Food insecurity;

19                   (2) Provide direct advice to the Secretary **AND THE STATE'S**  
 20 **INDEPENDENT HEALTH REGULATORY COMMISSIONS**, and indirect advice to the  
 21 Department's senior administrators and planners through the Secretary, regarding issues  
 22 of racial, ethnic, cultural, or socioeconomic health disparities;

23                   (3) Facilitate coordination of the expertise and experience of the State's  
 24 health and human services, housing, transportation, education, environment, community  
 25 development, and labor systems in developing a comprehensive health equity plan  
 26 addressing the social determinants of health; and

27                   (4) Set goals for health equity and prepare a plan for the State to achieve  
 28 health equity in alignment with any other statewide planning activities.

29                   (b) The Commission, using a health equity framework, shall:

1 (1) Examine and make recommendations regarding:

2 (i) Health considerations that may be incorporated into the  
3 decision-making processes of government agencies and private sector stakeholders who  
4 interact with government agencies;

5 (ii) Requirements for implicit bias training for clinicians engaged in  
6 patient care and whether the State should provide the training;

7 (iii) Training for health care providers on consistent and proper  
8 collection of patient self-identified race, ethnicity, and language data to identify disparities  
9 accurately; and

10 (iv) Requirements to comply with, and for enforcement of, National  
11 Standards for Culturally and Linguistically Appropriate Services in Health and Health  
12 Care (CLAS Standards);

13 (2) Foster collaboration between units of the State and local government  
14 and develop policies to improve health and reduce health inequities;

15 (3) Identify measures for monitoring and advancing health equity in the  
16 State;

17 (4) Establish a State plan for achieving health equity in alignment with  
18 other statewide planning activities in coordination with the State's health and human  
19 services, housing, transportation, education, environment, community development, and  
20 labor systems; [and]

21 (5) Make recommendations and provide advice, including direct advice to  
22 the Secretary, on implementing laws and policies to improve health and reduce health  
23 inequities; AND

24 **(6) DEVELOP AND MONITOR A STATEWIDE HEALTH EQUITY PLAN AS**  
25 **REQUIRED BY THE CENTER FOR MEDICARE AND MEDICAID INNOVATION UNDER**  
26 **ANY AGREEMENT ENTERED INTO BETWEEN THE STATE AND THE CENTERS FOR**  
27 **MEDICARE AND MEDICAID SERVICES.**

28 (c) (1) The Commission may establish advisory committees to assist the  
29 Commission in the performance of its duties under this section.

30 (2) An advisory committee established under this subsection may include  
31 individuals who are not members of the Commission.

1 (a) (1) The Commission shall, in coordination with **THE DEPARTMENT, THE**  
2 **HEALTH SERVICES COST REVIEW COMMISSION, AND** the State designated health  
3 information exchange, establish an advisory committee to make recommendations on data  
4 collection, needs, quality, reporting, evaluation, and visualization for the Commission to  
5 carry out the purposes of this subtitle.

6 (2) The advisory committee shall include representatives from the State  
7 designated health information exchange.

8 (3) The advisory committee shall define the parameters of a health equity  
9 data set to be maintained by the State designated health information exchange, including  
10 indicators for:

11 (i) Social and economic conditions;

12 (ii) Environmental conditions;

13 (iii) Health status;

14 (iv) Behaviors;

15 (v) Health care; and

16 (vi) Priority health outcomes for monitoring health equity for racial  
17 and ethnic minority populations in the State.

18 (4) The data set for which parameters are defined under paragraph (3) of  
19 this subsection shall include data from:

20 (i) Health care facilities that report to the Health Services Cost  
21 Review Commission;

22 (ii) Health care payers that report to the Maryland Health Care  
23 Commission; and

24 (iii) Any other data source the advisory committee determines  
25 necessary.

26 (5) Data shall be reported in the aggregate if it is reported:

27 (i) To the public; or

28 (ii) From the State designated health information exchange to the  
29 Commission.



1           (6) If the advisory committee makes a recommendation that data be made  
2 available to the public, the recommendation shall comply with applicable federal and State  
3 privacy law.

4           (b) (1) The Commission may request data consistent with the  
5 recommendations of the advisory committee.

6           (2) Data requested by the Commission under paragraph (1) of this  
7 subsection shall be provided, to the extent authorized by federal and State privacy law, to:

8                   (i) The Commission; or

9                   (ii) The State designated exchange.

10          (c) The Commission may publish or provide to the public any data collected under  
11 this section consistent with the recommendations of the advisory committee established  
12 under subsection (a) of this section.

13          SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
14 October 1, 2024.
