- **(1)** 11 FOR ON-PREMISES CONSUMPTION, OF ANY BEER, WINE, OR 12 LIQUOR; AND

- FOR OFF-PREMISES CONSUMPTION, ONLY OF THE BEER, WINE, OR 14 LIQUOR THAT IS MANUFACTURED ON THE PREMISES.
- 15 **(D)** THE LICENSE MAY NOT BE ISSUED FOR USE BY A DRUGSTORE.
