## A BILL ENTITLED

1 AN ACT concerning

2 **State Board of Cosmetologists – Membership – Alteration**

3 FOR the purpose of altering the membership of the State Board of Cosmetologists; and  
4 generally relating to the State Board of Cosmetologists.

5 BY repealing and reenacting, without amendments,  
6 Article – Business Occupations and Professions  
7 Section 5–201

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
16 That the Laws of Maryland read as follows:

17 **Article – Business Occupations and Professions**

18 5–201.

19 There is a State Board of Cosmetologists in the Department.

20 5–202.

21 (a) (1) The Board consists of seven members.

22 (2) Of the seven members of the Board:

6 (3) The Governor shall appoint the members with the advice of the  
7 Secretary.

8 (c) ~~[Each]~~ **THE** consumer member of the Board:

9 (1) shall be a member of the general public;

10 (2) may not be a licensee or otherwise be subject to regulation by the Board;

11 (3) may not be required to meet the qualifications for the professional  
12 members of the Board; and

13 (4) may not, within 1 year before appointment, have had a financial  
14 interest in or have received compensation from a person regulated by the Board.

15 (d) While a member of the Board, ~~[a]~~ **THE** consumer member may not:

16 (1) have a financial interest in or receive compensation from a person  
17 regulated by the Board; or

18 (2) grade any examination given by or for the Board.

19 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
20 October 1, 2024.
