Frederick County Board of Education - Discipline Regulations

- 3 FOR the purpose of authorizing the Frederick County Board of Education to follow or 4 to disregard certain discipline guidelines established by the State Board of 5 Education when adopting certain discipline regulations for the schools under 6 the jurisdiction of the county board; establishing that certain regulations of the 7 county board shall prevail if there is a conflict between certain State Board 8 guidelines and regulations and certain county board regulations; and generally 9 relating to the authority of the Frederick County Board of Education regarding certain discipline guidelines and regulations. 10

- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:
- 18 Article Education
- 19 7–306.
- 20 (a) Notwithstanding any bylaw, rule, or regulation made or approved by the State Board, a principal, vice principal, or other employee may not administer corporal punishment to discipline a student in a public school in the State.
- 23 (b) The State Board of Education shall:

- 1 (1) Establish guidelines that define a State code of discipline for all public schools with standards of conduct and consequences for violations of the standards; and
- 4 (2) Assist each county board with the implementation of the 5 guidelines.
- 6 (c) (1) [Subject to the provisions of subsections (a) and (b) of this section, 7 each] **EACH** county board shall adopt regulations designed to create and maintain 8 within the schools under its jurisdiction the atmosphere of order and discipline 9 necessary for effective learning.
- 10 (2) The regulations adopted by a county board under this subsection:
- 11 (I) SHALL BE SUBJECT TO THE PROVISIONS OF 12 SUBSECTION (A) OF THIS SECTION;
- 13 (II) EXCEPT AS PROVIDED IN PARAGRAPH (3) OF THIS 14 SUBSECTION, SHALL BE SUBJECT TO THE PROVISIONS OF SUBSECTION (B) OF THIS SECTION;
- 16 **[(i)] (III)** Shall provide for educational and behavioral 17 interventions, counseling, and student and parent conferencing; and
- [(ii)] (IV) Shall provide alternative programs, which may include in–school suspension, suspension, expulsion, or other disciplinary measures that are deemed appropriate.
- 21 (3) (I) THE REGULATIONS ADOPTED BY THE FREDERICK 22 COUNTY BOARD OF EDUCATION UNDER THIS SUBSECTION:
- 1. MAY FOLLOW THE GUIDELINES ESTABLISHED BY
 THE STATE BOARD UNDER SUBSECTION (B) OF THIS SECTION IF THE COUNTY
 BOARD DETERMINES THAT THE GUIDELINES ARE APPROPRIATE FOR THE
 SCHOOLS UNDER THE JURISDICTION OF THE STATE BOARD; OR
- 27 2. MAY DISREGARD ALL OR A PORTION OF THE
 28 GUIDELINES ESTABLISHED BY THE STATE BOARD UNDER SUBSECTION (B) OF
 29 THIS SECTION IF THE COUNTY BOARD DETERMINES THAT THE GUIDELINES ARE
 30 NOT APPROPRIATE FOR THE SCHOOLS UNDER THE JURISDICTION OF THE
 31 STATE BOARD.
- 32 (II) EXCEPT AS REQUIRED UNDER PARAGRAPH (2) OF THIS 33 SUBSECTION, IF THERE IS ANY CONFLICT BETWEEN ANY OTHER PROVISIONS OF 34 THE STATE BOARD GUIDELINES OR REGULATIONS AND THE FREDERICK

- 1 COUNTY BOARD OF EDUCATION REGULATIONS ADOPTED UNDER THIS
- 2 SUBSECTION, THE REGULATIONS OF THE FREDERICK COUNTY BOARD OF
- 3 EDUCATION SHALL PREVAIL.
- 4 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 5 July 1, 2014.
