## A BILL ENTITLED

1 AN ACT concerning

2 **Prince George's County – School Board Districts – Redistricting Plan**

3 **PG 507–22**

4 FOR the purpose of altering the boundaries of the school board districts for election of the  
5 members of the Prince George's County Board of Education; and generally relating  
6 to the school board districts for the Prince George's County Board of Education.

7 BY repealing and reenacting, with amendments,

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

11           SECTION 2. AND BE IT FURTHER ENACTED, That this Act is an emergency  
12 measure, is necessary for the immediate preservation of the public health or safety, has  
13 been passed by a ye and nay vote supported by three-fifths of all the members elected to  
14 each of the two Houses of the General Assembly, and shall take effect from the date it is  
15 enacted.
