4 Maryland for the election of members to the United States House of Representatives;

21 Preamble

22 WHEREAS, The decennial census, mandated under Article I, § 2 of the U.S.
23 Constitution, informs the reapportionment and redistricting process, with the last census
24 occurring in 2020; and

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

1 WHEREAS, Each state is allowed to adopt a congressional redistricting process that
2 applies to its particular needs; and

3 WHEREAS, Free and fair elections are the right of every citizen in the United States;
4 and

5 WHEREAS, The Governor established the Maryland Citizens Redistricting
6 Commission, a balanced citizens' commission consisting of equal numbers of nonlegislator
7 Democrats, Republicans, and Independents, for the purpose of creating a congressional
8 districting plan that is free from political influence, and to the extent practical respects
9 natural boundaries, boundaries of political subdivisions, and provides communities with a
10 voice, while respecting the principle of "one person, one vote"; and

11 WHEREAS, The congressional redistricting plan prepared by the Maryland Citizens
12 Redistricting Commission will enable a larger number of Marylanders to fully participate
13 in the choosing of their representatives; now, therefore,

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
15 That Section(s) 8-702 through 8-709 of Article – Election Law of the Annotated Code of
16 Maryland be repealed.

17 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read
18 as follows:

19 **Article – Election Law**

20 8-701.

21 (a) (1) The population count used after each decennial census for the purpose
22 of creating the congressional districting plan used to elect the State's Representatives in
23 Congress:

24 (i) may not include individuals who:

25 1. were incarcerated in State or federal correctional facilities,
26 as determined by the decennial census; and

27 2. were not residents of the State before their incarceration;
28 and

29 (ii) shall count individuals incarcerated in the State or federal
30 correctional facilities, as determined by the decennial census, at their last known residence
31 before incarceration if the individuals were residents of the State.

32 (2) Beginning with the 2020 decennial census:

1 (i) on or before October 31 in the year of each decennial census, the
2 Department of Public Safety and Correctional Services shall submit to the Maryland
3 Department of Planning and the Department of Legislative Services the following
4 identifiable information, in electronic form, for each individual incarcerated in a State
5 correctional facility on April 1 in the year of the decennial census:

- 6 1. the name of the individual;
- 7 2. the address of the individual's last known residence;
- 8 3. the individual's race or ethnicity; and
- 9 4. any other information necessary to fulfill the purposes of

10 this section; and

11 (ii) on or before August 1 in the year of each decennial census, the
12 Maryland Department of Planning and the Department of Legislative Services shall enter
13 into a memorandum of understanding, the terms of which shall require the Department of
14 Planning and the Department of Legislative Services to work collaboratively to:

- 15 1. summarize the results of the geocoded data created by the
16 Department of Planning as required under COMAR 35.05.01;
- 17 2. using the geocoded data, identify the individuals
18 incarcerated in a State correctional facility or federal correctional facility in the State that
19 will be included in the adjusted census data under this section;
- 20 3. make any necessary changes to the Department of
21 Planning's geocoded database;
- 22 4. jointly review for accuracy any changes to the census data
23 by any software vendor or other entity; and
- 24 5. jointly certify, on or before March 15 in the year following
25 each decennial census, the adjusted census data to be used for redistricting under this
26 section.

27 (b) The State is divided into eight districts for the election of the State's
28 Representatives in Congress.

29 (c) (1) The descriptions of congressional districts in this subtitle include the
30 references indicated.

31 (2) (i) The references to:

32 1. election districts and wards are to the geographical
33 boundaries of the election districts and wards as they existed on April 1, [2010] **2020**; and

1 2. precincts are to the geographical boundaries of the
2 precincts as reviewed and certified by the local boards or their designees, before they were
3 reported to the U.S. Bureau of the Census as part of the [2010] **2020** census redistricting
4 data program and as those precinct lines are specifically indicated in the P.L. 94–171 data
5 or shown on the P.L. 94–171 census block maps provided by the U.S. Bureau of the Census
6 and as reviewed and corrected by the Maryland Department of Planning.

7 (ii) Where precincts are split between congressional districts, census
8 tract and block numbers, as indicated in P.L. 94–171 data or shown on the P.L. 94–171
9 census block maps provided by the U.S. Bureau of the Census and referred to in this
10 subtitle, are used to define the boundaries of congressional districts.
