- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 2 That the Laws of Maryland read as follows:

- 6 (a) In this subtitle the following words have the meanings indicated.
- 7 (b) "Office" means the Office of Smart Growth.
- 8 (c) "Special Secretary" means the Special Secretary of Smart Growth.
- 9 (d) "Subcabinet" means the Smart SUSTAINABLE Growth Subcabinet.
- 10 (C) "SUSTAINABLE GROWTH POLICY" MEANS THE STATE ECONOMIC
- 11 GROWTH, RESOURCE PROTECTION, AND PLANNING POLICY SET FORTH IN §
- 12 5-7A-01 OF THE STATE FINANCE AND PROCUREMENT ARTICLE.

- 14 (a) The General Assembly finds that the State is committed to addressing the
- 15 high financial, social, and environmental costs of sprawl development through effective
- 16 [smart] SUSTAINABLE growth policy.
- 17 (b) The purpose of this subtitle is to establish a centralized office in the State in
- a manner such that the policy of [smart] SUSTAINABLE growth can be better articulated,
- 19 coordinated, and implemented in order to better serve the residents of the State.

- 24 (a) The head of the Office is the Special Secretary of Smart Growth, who shall be

- 4 (2) Subject to the provisions of this subtitle, the Special Secretary may
 5 establish, reorganize, or abolish areas of responsibility in the Office as necessary to fulfill
 6 the duties assigned to the Special Secretary.
- 7 (3) The Special Secretary may adopt regulations necessary to carry out the provisions of this subtitle.
- 9 (d) The Special Secretary is entitled to the salary provided in the State budget.]

- 11 (a) In addition to any other powers and duties imposed by law, the [Office]
 12 SUBCABINET has the powers and duties set forth in this section.
- 13 (b) The [Office] SUBCABINET shall:
- 14 (1) review State assistance programs related to [smart] SUSTAINABLE 15 growth to determine their applicability, if any, to projects that are consistent with the 16 State's [smart] SUSTAINABLE growth policy;
- 17 (2) promote interagency consensus and cooperation on projects that are
 18 consistent with the State's [smart] SUSTAINABLE growth policy and resolve conflicting
 19 agency positions on projects in an expedited manner;
- 20 (3) provide advisory and technical assistance to local jurisdictions and to the public in preparing, financing, and developing [smart] SUSTAINABLE growth and neighborhood [conservation] VITALITY projects;
- 23 (4) gather and disseminate information to the public, including local 24 jurisdictions, nonprofit organizations, and developers on how to develop projects that are 25 consistent with the State's [smart] SUSTAINABLE growth policy;
- 26 (5) provide a single point of access for members of the public, including local jurisdictions, nonprofit organizations, developers, and community and homeowners' associations who need assistance or guidance in navigating the processes and regulations of State agencies on projects that are consistent with the State's [smart] SUSTAINABLE growth policy;

11 12	(2) The Secretary of [Planning] HOUSING AND COMMUNITY DEVELOPMENT shall be the vice chair of the Subcabinet.
13 14	(e) (1) The Office DEPARTMENT OF PLANNING shall provide the primary staff support for the Subcabinet AND SERVE AS ITS PRIMARY OFFICE.
15 16	(2) The [Special Secretary and the] Secretary of Planning may call upon any of the Subcabinet members to provide additional staff assistance as needed.
17 18	(f) The [Special Secretary and the] Secretary of Planning may establish subcommittees to carry out the work of the Subcabinet.
19	(g) The Subcabinet shall meet regularly at such times and places as it determines.

26 27	(iii) work together to create, enhance, support, and revitalize EQUITABLE AND sustainable communities across the State;
28	(iv) meet at least biannually with county and municipal elected

leaders and planning officials to discuss local government issues relating to activities that

- 1 affect smart EQUITABLE AND RESILIENT growth, development, neighborhood 2 conservation VITALITY, and resource management;
- 3 (v) subject to paragraph (2) of this subsection, make 4 recommendations to:
- 5 1. the Department of Commerce in accordance with § 5–1304 6 of the Economic Development Article;
- 7 2. the Department of Housing and Community Development 8 in accordance with § 6–206 of the Housing and Community Development Article;
- 9 3. the Department of Planning in accordance with § 5A–303 10 of the State Finance and Procurement Article; and
- 11 4. the Department of Transportation in accordance with § 12 7–101 of the Transportation Article;
- 13 (vi) in coordination with State agencies, evaluate and report 14 annually to the Governor and, in accordance with § 2–1257 of this article, to the General 15 Assembly on the implementation of the State's smart SUSTAINABLE growth policy; and
- 16 (vii) perform other duties assigned by the Governor.
- 17 (2) The failure of the Subcabinet to make a recommendation under 18 paragraph (1)(v) of this subsection may not be construed as prohibiting a department to act 19 in accordance with the department's authority under State law.
- 20 (i) The annual report required in subsection (h)(1) of this section shall include:
- 21 (1) a description of the projects, programs, and costs of activities located in 22 priority funding areas;
- 23 (2) a description of projects, programs, and costs of activities funded under 24 the exceptions allowed in § 5–7B–06 of the State Finance and Procurement Article;
- 25 (3) projects submitted to the Board of Public Works for funding outside 26 priority funding areas under the extraordinary circumstances exception in accordance with 27 § 5–7B–05 of the State Finance and Procurement Article and the impact of these projects 28 upon the State's smart SUSTAINABLE growth policy;
- 29 (4) a list of programs and policies reviewed and changed to ensure 30 compliance with the State's smart SUSTAINABLE growth policy; and
- 31 (5) a list of projects or programs approved and funded under Chapter 759, 32 § 2 of the Acts of 1997.
