

- (a) In addition to the modification under § 10–207 of this subtitle, the amounts under this section are subtracted from the federal adjusted gross income of a resident to determine Maryland adjusted gross income.
- (i-1) (1) The subtraction under subsection (a) of this section includes an amount equal to the amount specified in paragraph (3) of this subsection if an individual is a qualifying volunteer fire, rescue, or emergency medical services member for the taxable year, as determined under paragraph (2) of this subsection.
- (2) An individual is a qualifying volunteer fire, rescue, or emergency medical services member for the taxable year eligible for the subtraction modification under this subsection if the individual:
- 11 (i) is an active member of:
- 12 a bona fide Maryland fire, rescue, or emergency medical services organization;
- 14 2. an auxiliary organization of a bona fide Maryland fire, 15 rescue, or emergency medical services organization;
- 16 3. the United States Coast Guard Auxiliary;
- 17 4. the Maryland Defense Force; or
- 18 5. the Maryland Civil Air Patrol;
- 19 (ii) serves the organization in a volunteer capacity without 20 compensation, except nominal expenses or meals;
- 21 (iii) 1. qualifies for active status during the taxable year under:
- A. a volunteer fire, rescue, or emergency medical services personnel or auxiliary length of service award program operated by a county or municipal corporation of the State, if the length of service award program requires for active status qualification a minimum of 50 points per year and that points be earned in at least two different categories; or
 - B. a point system established by a county or municipal corporation that does not operate a volunteer fire, rescue, or emergency medical services personnel or auxiliary length of service award program or by the United States Coast Guard Auxiliary, the Maryland Defense Force, or the Maryland Civil Air Patrol, to identify active members of a volunteer fire, rescue, or emergency medical services organization or auxiliary organization, if the point system requires for active status qualification a minimum of 50 points per year and that points be earned in at least two different categories;



- 29 (4) (i) Each fire, rescue, or emergency medical services organization or 30 auxiliary organization shall:
- 31 maintain a record of the points earned by each individual 32 during each calendar year;
- 2. provide each member a report identifying the number of points earned in each category by February 15 of the following year; and

- 3. provide a report that includes the names, Social Security numbers, and points earned by those members qualifying for the subtraction modification under this subsection to the Maryland State Firemen's Association by May 1 of the following year.
- 5 (ii) An individual may not qualify for the subtraction under this 6 subsection based on membership in the United States Coast Guard Auxiliary, the Maryland 7 Defense Force, or the Maryland Civil Air Patrol unless the United States Coast Guard 8 Auxiliary, the Maryland Defense Force, or the Maryland Civil Air Patrol:
- 9 ... maintains a record of the points earned by each individual 10 during each calendar year;
- provides each member a report identifying the number of points earned in each category by February 15 of the following year; and
- 3. provides a report that includes the names, Social Security numbers, and points earned by those members qualifying for the subtraction modification under this subsection to the Comptroller on or before October 1 of each year.
- 16 (5) To qualify for the subtraction modification under this subsection, an individual shall attach to the individual's income tax return a copy of the report provided by the organization under paragraph (4) of this subsection.
- 19 (6) On or before October 1 of each year, the Maryland State Firemen's Association shall submit to the Department of Public Safety and Correctional Services and the Office of the Comptroller a report stating the participation in the point system by the various local subdivisions with the names and Social Security numbers of individuals who qualified for the subtraction modification under this subsection for the preceding taxable year.
- 25 (7) (i) A person may not knowingly make or cause any false statement 26 or report to be made in any application or in any document required under this subsection.
- 27 (ii) Any person who violates or attempts to violate any provision of subparagraph (i) of this paragraph shall be subject to a fine of \$1,000.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July $30-1,\,2019.$
