CHAPTER _____

1 AN ACT concerning

2 **School Bus Monitoring Cameras – Exclusion of Vehicle Rental**
3 **Companies – Repeal and Notification Requirement**

4 FOR the purpose of altering a certain definition to repeal the exclusion of motor vehicle
5 rental companies as owners of motor vehicles for the purpose of the enforcement of
6 violations of overtaking and passing school vehicles operating alternately flashing
7 red lights that are recorded by school bus monitoring cameras; requiring a law
8 enforcement agency to provide a certain notice to a motor vehicle rental company
9 before issuing a certain citation; prohibiting a law enforcement agency from mailing
10 a motor vehicle rental company a certain citation if the motor vehicle rental company
11 provides the law enforcement agency with certain information or pays a certain
12 penalty; making conforming changes; and generally relating to vehicle rental
13 companies and school bus monitoring cameras.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
2 That the Laws of Maryland read as follows:

3 **Article – Transportation**

4 21–706.1.

5 (a) (3) (i) “Owner” means the registered owner of a motor vehicle or a
6 lessee of a motor vehicle under a lease of 6 months or more.

7 (ii) “Owner” does not include:

8 1. A motor vehicle [rental or] leasing company; or

9 2. A holder of a special registration plate issued under Title
10 13, Subtitle 9, Part III of this article.

11 (e) (1) Unless the driver of the motor vehicle received a citation from a police
12 officer at the time of the violation, the owner or, in accordance with subsection (h)(5) of this
13 section, the driver of a motor vehicle is subject to a civil penalty if the motor vehicle is
14 recorded by a school bus monitoring camera during the commission of a violation.

15 (2) A civil penalty under this subsection may not exceed \$250.

16 (3) For purposes of this section, the District Court shall prescribe:

17 (i) A uniform citation form consistent with subsection (f)(1) of this
18 section and § 7–302 of the Courts Article; and

19 (ii) A civil penalty, which shall be indicated on the citation, to be paid
20 by persons who choose to prepay the civil penalty without appearing in District Court.

21 (f) (1) Subject to the provisions of paragraphs (2) through [(4)] (5) of this
22 subsection, a law enforcement agency shall mail to the owner liable under subsection (e) of
23 this section a citation that shall include:

24 (i) The name and address of the registered owner of the vehicle;

25 (ii) The registration number of the motor vehicle involved in the
26 violation;

27 (iii) The violation charged;

28 (iv) To the extent possible, the location of the violation;

29 (v) The date and time of the violation;

1 (vi) A copy of the recorded image;

2 (vii) The amount of the civil penalty imposed and the date by which
3 the civil penalty must be paid;

4 (viii) A signed statement by a technician employed by the law
5 enforcement agency that, based on inspection of recorded images, the motor vehicle was
6 being operated during the commission of a violation;

7 (ix) A statement that recorded images are evidence of a violation; and

8 (x) Information advising the person alleged to be liable under this
9 section:

10 1. Of the manner and time in which liability as alleged in the
11 citation may be contested in the District Court; and

12 2. That failure to pay the civil penalty or to contest liability
13 in a timely manner is an admission of liability and may result in refusal or suspension of
14 the motor vehicle registration.

15 (2) The law enforcement agency may mail a warning notice in place of a
16 citation to the owner liable under subsection (e) of this section.

17 (3) **(I) BEFORE MAILING A CITATION TO A MOTOR VEHICLE**
18 **RENTAL COMPANY LIABLE UNDER SUBSECTION (E) OF THIS SECTION, A LAW**
19 **ENFORCEMENT AGENCY SHALL MAIL A NOTICE TO THE MOTOR VEHICLE RENTAL**
20 **COMPANY STATING THAT A CITATION WILL BE MAILED TO THE MOTOR VEHICLE**
21 **RENTAL COMPANY UNLESS, WITHIN 45 DAYS OF RECEIVING THE NOTICE, THE**
22 **MOTOR VEHICLE RENTAL COMPANY PROVIDES THE LAW ENFORCEMENT AGENCY**
23 **WITH:**

24 1. **A STATEMENT MADE UNDER OATH THAT STATES THE**
25 **NAME AND LAST KNOWN MAILING ADDRESS OF THE INDIVIDUAL DRIVING OR**
26 **RENTING THE MOTOR VEHICLE WHEN THE VIOLATION OCCURRED;**

27 2. **A. A STATEMENT MADE UNDER OATH THAT**
28 **STATES THAT THE MOTOR VEHICLE RENTAL COMPANY IS UNABLE TO DETERMINE**
29 **WHO WAS DRIVING OR RENTING THE VEHICLE AT THE TIME THE VIOLATION**
30 **OCCURRED BECAUSE THE MOTOR VEHICLE WAS STOLEN AT THE TIME OF THE**
31 **VIOLATION; AND**

32 **B. A COPY OF THE POLICE REPORT ASSOCIATED WITH**
33 **THE MOTOR VEHICLE THEFT CLAIMED UNDER ITEM A OF THIS ITEM; OR**

1 **3. PAYMENT FOR THE PENALTY ASSOCIATED WITH THE**
 2 **VIOLATION.**

3 **(II) A LAW ENFORCEMENT AGENCY MAY NOT MAIL A CITATION**
 4 **TO A MOTOR VEHICLE RENTAL COMPANY LIABLE UNDER SUBSECTION (E) OF THIS**
 5 **SECTION IF THE MOTOR VEHICLE RENTAL COMPANY COMPLIES WITH**
 6 **SUBPARAGRAPH (I) OF THIS PARAGRAPH.**

7 **(4) Except as provided in PARAGRAPH (3) OF THIS SUBSECTION AND**
 8 **subsection (h)(5) of this section, a citation issued under this section shall be mailed no later**
 9 **than 2 weeks after the alleged violation.**

10 **[(4)] (5) A person who receives a citation under paragraph (1) of this**
 11 **subsection may:**

12 **(i) Pay the civil penalty, in accordance with instructions on the**
 13 **citation, directly to the county; or**

14 **(ii) Elect to stand trial for the alleged violation.**

15 (h) (5) (i) If the District Court finds that the person named in the citation
 16 was not operating the vehicle at the time of the violation or receives evidence under
 17 paragraph (4)(ii)2 of this subsection identifying the person driving the vehicle at the time
 18 of the violation, the clerk of the court shall provide to the law enforcement agency issuing
 19 the citation a copy of any evidence substantiating who was operating the vehicle at the time
 20 of the violation.

21 (ii) On the receipt of substantiating evidence from the District Court
 22 under subparagraph (i) of this paragraph, the law enforcement agency may issue a citation
 23 as provided in subsection (f) of this section to the person that the evidence indicates was
 24 operating the vehicle at the time of the violation.

25 (iii) A citation issued under subparagraph (ii) of this paragraph shall
 26 be mailed no later than 2 weeks after receipt of the evidence from the District Court.

27 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
 28 October 1, 2017.
