A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2007 – Anne Arundel County –**
3 **Hope House**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2007
5 to alter the type of matching fund that may be provided by the Board of
6 Directors of Addiction Recovery, Inc. for a certain capital project; providing that
7 certain grants may not terminate before a certain date; and generally relating
8 to amending the Maryland Consolidated Capital Bond Loan of 2007.

9 BY repealing and reenacting, with amendments,
10 Chapter 488 of the Acts of the General Assembly of 2007, as amended by
11 Chapter 707 of the Acts of the General Assembly of 2009
12 Section 1(3) Item ZA01(H) and Item ZA02(C)

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
14 MARYLAND, That the Laws of Maryland read as follows:

20 (H) Hope House. Provide a grant of \$100,000 to the Board of
21 Directors of Addiction Recovery, Inc. for the repair,
22 renovation, and capital equipping of Hope House, an alcohol
23 and drug addiction residential treatment facility, located in
24 Crownsville, subject to a requirement that the grantee provide
25 and expend a matching fund of \$50,000. Notwithstanding
