20 21	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

- 6 (d) The Secretary may not charge a fee under subsection (b) of this section to:

- 10 (a) [A] EXCEPT AS PROVIDED IN SUBSECTION (C) OF THIS SECTION, A
 11 permit expires on the last day of the holder's birth month following 2 years after the
 12 date the permit is issued.
- 13 (b) [A] EXCEPT AS PROVIDED IN SUBSECTION (C) OF THIS SECTION, A
 14 permit may be renewed for successive periods of 3 years each if, at the time of an
 15 application for renewal, the applicant possesses the qualifications for the issuance of a
 16 permit and pays the renewal fee stated in this subtitle.
- 17 (C) A PERMIT ISSUED TO A RETIRED LAW ENFORCEMENT OFFICER OF THE STATE OR A COUNTY OR MUNICIPAL CORPORATION OF THE STATE:
- 19 (1) EXPIRES ON THE LAST DAY OF THE HOLDER'S BIRTH MONTH 20 FOLLOWING 5 YEARS AFTER THE DATE THE PERMIT IS ISSUED; AND
- 21 (2) MAY BE RENEWED FOR SUCCESSIVE PERIODS OF 5 YEARS 22 EACH IF, AT THE TIME OF AN APPLICATION FOR RENEWAL, THE APPLICANT 23 POSSESSES THE QUALIFICATIONS FOR THE ISSUANCE OF A PERMIT.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2012.
