A BILL ENTITLED

1 AN ACT concerning

2 **Family Law – Termination of Alimony – Cohabitation of Recipient**

3 FOR the purpose of establishing that alimony terminates on the cohabitation of an
4 alimony recipient and a certain other individual under certain circumstances;
5 establishing that cohabitation is presumed under certain circumstances;
6 requiring that, on the marriage or cohabitation of the recipient, the recipient
7 notify the party who is required to pay alimony; and generally relating to the
8 termination of alimony.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
15 MARYLAND, That the Laws of Maryland read as follows:

16 **Article – Family Law**

17 11–108.

18 **(A)** Unless the parties agree otherwise, alimony terminates:

19 (1) on the death of either party;

20 (2) on the marriage of the recipient; [or]

1 **(3) ON THE COHABITATION OF THE RECIPIENT FOR A PERIOD OF**
2 **AT LEAST 30 DAYS WITH AN INDIVIDUAL WHO IS NOT A MEMBER OF THE**
3 **RECIPIENT'S FAMILY; OR**

4 **[(3)] (4)** if the court finds that termination is necessary to avoid a
5 harsh and inequitable result.

6 **(B) IN THIS SECTION, COHABITATION SHALL BE PRESUMED IF:**

7 **(1) THE RECIPIENT RESIDED WITH THE OTHER INDIVIDUAL FOR**
8 **THE PERIOD SPECIFIED IN SUBSECTION (A)(3) OF THIS SECTION;**

9 **(2) THE RECIPIENT AND THE OTHER INDIVIDUAL ENGAGED IN A**
10 **RELATIONSHIP OF A ROMANTIC NATURE; AND**

11 **(3) THE RECIPIENT PROVIDED ANY ECONOMIC BENEFIT TO OR**
12 **RECEIVED ANY ECONOMIC BENEFIT FROM THE OTHER INDIVIDUAL AS A RESULT**
13 **OF THE RELATIONSHIP.**

14 **(C) ON THE MARRIAGE OR COHABITATION OF THE RECIPIENT, THE**
15 **RECIPIENT SHALL IMMEDIATELY NOTIFY THE PARTY WHO IS REQUIRED TO PAY**
16 **ALIMONY.**

17 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
18 October 1, 2011.
