BY repealing and reenacting, with amendments, Article – Real Property Section 14-125 Annotated Code of Maryland (2015 Replacement Volume and 2017 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: Article - Real Property 14-125.(a) In this section the following words have the meanings indicated. (1)

12 13 14 15	(2) (i) An action may not be brought under this section based on a nuisance until 60 days after the community association gives notice of the violation and of the community association's intent to bring an action under this section by certified mail, return receipt requested, to the County Code enforcement agency.
16 17	(ii) An action under this section may not be brought if the County Code enforcement agency has filed an action for equitable relief from the nuisance.
18 19 20 21	(3) (i) An action may not be brought under this section until 60 days after the tenant, if any, and owner of record receive notice by certified mail, return receipt requested, from the community association that a nuisance exists and that legal action may be taken if the nuisance is not abated.
22	(ii) The notice shall specify:
23	1. The nature of the alleged nuisance;
24 25	2. The date and time of day the nuisance was first documented;
26 27	3. The location on the property where the nuisance is allegedly occurring; and
