1 AN ACT concerning

Criminal Law – Use or Possession of a Controlled Dangerous Substance – De Minimis Quantity

4 FOR the purpose of making certain violations relating to the use or possession of certain 5 de minimis quantities of certain controlled dangerous substances a civil offense 6 rather than a misdemeanor; applying penalties for a first or second finding of guilt 7 involving the use or possession of less than 10 grams of marijuana to a first or second 8 finding of guilt involving the use or possession of a de minimis quantity of certain 9 controlled dangerous substances; applying certain procedural provisions relating to 10 issuance of a citation for use or possession of less than 10 grams of marijuana to a first or second finding of guilt involving the use or possession of a de minimis 11 quantity of certain controlled dangerous substances; altering a certain provision of 12 13 law to require a court to order a person who commits a certain violation, regardless 14 of the age of the person, to attend a certain drug education program, refer the person 15 to an assessment for substance use disorder, and refer the person to substance use 16 treatment under certain circumstances; defining a certain term; making conforming 17 changes; making technical changes; and generally relating to use or possession of a 18 controlled dangerous substance.
