3 FOR the purpose of ~~requiring each county and municipality to adopt a certain policy;~~
4 ~~altering a State policy regarding the payment of certain funds after receipt of a~~
5 ~~proper invoice;~~ reducing the number of days following receipt of an invoice after
6 which ~~the State owes interest on unpaid amounts and~~ interest begins to accrue on
7 certain unpaid procurement contract amounts; ~~repealing a requirement that a~~
8 ~~contractor submit an invoice within a certain amount of time in order to receive~~
9 ~~interest payments;~~ requiring the Department of Legislative Services to submit a
10 certain report to the General Assembly on or before a certain date; *requiring the*
11 *Department of Information Technology to submit a certain report to the General*

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
14 That the Laws of Maryland read as follows:

29 (a) Except as provided in § 15–105 of this subtitle, interest shall accrue at the
30 rate of 9% per annum on any amount that:

31 (1) is due and payable by law and under the written procurement contract;

1 (2) remains unpaid more than [45] ~~45~~ 37 days after a unit receives an
2 invoice.

3 (b) Interest shall accrue beginning on the ~~[31st]~~ ~~16TH~~ day after:

4 (1) the day on which payment becomes due under a procurement contract;

6 (2) if later, the day on which the unit receives an invoice.

8 ~~A unit is not liable under § 15-104 of this subtitle for interest:~~

9 (1) ~~[unless within 30 days after the date on the State's check for the~~
10 ~~amount on which the interest accrued, the contractor submits an invoice for the interest;~~

12 ~~[(3)] (2) accruing more than 1 year after the [31st] 16TH day after the~~

15 SECTION 2. AND BE IT FURTHER ENACTED, That, on or before December 1,
16 2022, the Department of Legislative Services shall report to the General Assembly, in
17 accordance with § 2-1257 of the State Government Article, on:

18 (1) for each unit of State government:

19 (i) the number of unit staff whose work responsibilities involve
20 processing procurement contract payments;

21 (ii) the number of vacancies for positions that would be assigned to
22 process procurement contract payment; and

23 (iii) for at least the prior 3 fiscal years:

24 1. the average time for the unit to process a procurement
25 contract payment;

26 2. the percentage of procurement contract payments that
27 are;

1 A. paid within 30 days after the day on which the payment
2 becomes due under the procurement contract;

3 B. paid after 30 days but less than 37 days after the day on
4 which the payment becomes due under the procurement contract;

5 C. paid after 37 days but less than 45 days after the day on
6 which the payment becomes due under the procurement contract; and

7 D. paid 45 days or more after the day on which the payment
8 becomes due under the procurement contract; and

9 3. the amount of interest paid by the unit for late payments
10 made on procurement contract invoices;

11 (2) based on the information obtained under item (1) of this section, the
12 fiscal impact to the State of:

13 (i) reducing the number of days following receipt of an invoice after
14 which the State owes interest on unpaid amounts; and

15 (ii) reducing the number of days following receipt of an invoice after
16 which interest begins to accrue on unpaid amounts; and

17 (3) the status of the upgrade of the Comptroller's online payment
18 processing portal.

19 SECTION 3. AND BE IT FURTHER ENACTED, That:

20 (a) On or before December 1, 2022, the Department of Information Technology, in
21 consultation with the Comptroller, the Department of Budget and Management, the
22 Department of Transportation, the Department of General Services, and the State Treasurer,
23 shall report on:

24 (1) the status of the upgrade of the Comptroller's online payment processing
25 portal;

26 (2) the status of plans to upgrade the State's Financial Management
27 Information System, including target dates for critical project milestones;

28 (3) the status of plans to ensure all units of government engaging in
29 procurement utilize electronic systems for the processing of payments; and

30 (4) the extent to which all electronic payment processing systems used by
31 units of State government can be integrated into one central electronic system.

1 (b) The report required under subsection (a) of this section shall be submitted to
2 the General Assembly, in accordance with § 2-1257 of the State Government Article, on or
3 before December 1, 2022.

4 (c) It is the intent of the General Assembly that any plans for the upgrade of the
5 State's Financial Management Information System include goals to significantly reduce the
6 amount of time in which payments are processed.

7 ~~SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect~~
8 ~~October 1, 2022.~~

9 SECTION 3. 4. AND BE IT FURTHER ENACTED, That Section 1 of this Act shall
10 take effect June 1, 2023.

11 SECTION 4. 5. AND BE IT FURTHER ENACTED, That, except as provided in
12 Section 3 4 of this Act, this Act shall take effect July 1, 2022.
