## A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2010 – Prince George’s County**  
3 **– Community Forklift Facility**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2010  
5 to extend the deadline for the Board of Directors of the Sustainable Community  
6 Initiatives, Inc. to present evidence that a matching fund will be provided;  
7 requiring the Board of Public Works to expend or encumber the proceeds of the  
8 loan by June 1, 2013; and generally relating to an amendment to the Maryland  
9 Consolidated Capital Bond Loan of 2010.

10 BY repealing and reenacting, with amendments,  
11 Chapter 483 of the Acts of the General Assembly of 2010  
12 Section 1(3) Item ZA02(BB) and Item ZA03(AZ)

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
14 MARYLAND, That the Laws of Maryland read as follows:

### 15 **Chapter 483 of the Acts of 2010**

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
17 MARYLAND, That:

18 (3) ZA02 LOCAL SENATE INITIATIVES

19 (BB) Community Forklift Facility. Provide a grant equal to the  
20 lesser of (i) \$100,000 or (ii) the amount of the matching fund  
21 provided, to the Board of Directors of the Sustainable  
22 Community Initiatives, Inc. for the acquisition, construction,  
23 and repair of the Community Forklift Facility, located in  
24 Edmonston (Prince George’s County). **NOTWITHSTANDING**
