A BILL ENTITLED

1 AN ACT concerning

2 **Education – Tween/Teen Dating Violence**
3 **(Kristin Marie Mitchell Law)**

4 FOR the purpose of requiring the State Board of Education to adopt in the public
5 schools a program to educate students about dating violence on or before a
6 certain date; requiring the program to include education on services provided to
7 victims of dating violence; requiring the program to be started in each public
8 school before a certain grade; altering the definition of “victim of domestic
9 violence” for purposes of certain provisions of law to include a certain person;
10 requiring the Governor to proclaim the first week in February each year
11 “Tween/Teen Dating Violence Education and Awareness Week”; and generally
12 relating to dating violence.

7 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
8 MARYLAND, That the Laws of Maryland read as follows:

9 **Article – Education**

10 7–411.1.

11 The State Board shall encourage the county boards to incorporate
12 age-appropriate lessons on dating violence into the county boards’ health education
13 curriculum.

14 **7–411.2.**

15 **(A) ON OR BEFORE JANUARY 1, 2012, THE STATE BOARD SHALL ADOPT**
16 **A PROGRAM IN THE PUBLIC SCHOOLS TO EDUCATE STUDENTS ABOUT DATING**
17 **VIOLENCE.**

18 **(B) A PROGRAM ADOPTED UNDER SUBSECTION (A) OF THIS SECTION**
19 **SHALL INCLUDE EDUCATION ON SERVICES PROVIDED TO VICTIMS OF DATING**
20 **VIOLENCE.**

21 **(C) THE PROGRAM SHALL BE STARTED IN EACH PUBLIC SCHOOL**
22 **BEFORE THE SIXTH GRADE.**

25 In this Part III and in Part IV of this subtitle, “victim of domestic violence”
26 means an individual who has received deliberate, severe, and demonstrable physical
27 injury, or is in fear of imminent deliberate, severe, and demonstrable physical injury
28 from a current or former spouse, or a current or former cohabitant, as defined in §
29 4–501 of this subtitle, **OR A PERSON WITH WHOM THE INDIVIDUAL HAS OR HAS**
30 **HAD A DATING RELATIONSHIP.**

32 **SUBTITLE 6. COMMEMORATIVE WEEKS.**

2 **THE GOVERNOR SHALL PROCLAIM THE FIRST WEEK OF FEBRUARY EACH**
3 **YEAR AS TWEEN/TEEN DATING VIOLENCE EDUCATION AND AWARENESS WEEK.**

4 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
5 October 1, 2011.
