- 5 FOR the purpose of authorizing the State Board of Examiners for Audiologists, 6 Hearing Aid Dispensers, and Speech-Language Pathologists to issue cease and 7 desist orders or obtain injunctive relief for violations of certain provisions of 8 law; authorizing an action to be maintained in the name of the State or the Board to enjoin certain unauthorized practice or conduct that is a ground for 9 10 certain disciplinary action; authorizing a certain action to be brought by certain 11 persons and in certain locations; providing that proof of certain damages is not 12 required for a certain action; providing that a certain action is in addition to and 13 not instead of certain criminal prosecution or disciplinary action; repealing authorization for the Board to sue to enforce certain provisions of law; and 14 generally relating to the State Board of Examiners for Audiologists, Hearing 15 Aid Dispensers, and Speech-Language Pathologists and cease and desist orders 16 17 and injunctive relief.
