CHAPTER _____

1 AN ACT concerning

2 **Marriage – Confidential Communication – ~~Criminal Charge~~**

3 FOR the purpose of clarifying that “spouse” includes a former spouse for purposes of
4 disclosure of confidential communications occurring during marriage; establishing
5 that a certain spouse is competent to disclose a certain confidential communication
6 in a criminal action in which one spouse is charged with a crime against the other
7 spouse; and generally relating to confidential communications occurring during
8 marriage.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
15 That the Laws of Maryland read as follows:

16 **Article – Courts and Judicial Proceedings**

17 9–105.

18 **(A) IN THIS SECTION, “SPOUSE” INCLUDES A FORMER SPOUSE.**

1 ~~(A)~~ (B) [One] EXCEPT AS PROVIDED IN SUBSECTION ~~(B)~~ (C) OF THIS
2 SECTION, ONE spouse is not competent to disclose any confidential communication
3 between the spouses occurring during their marriage.

4 ~~(B)~~ (C) (1) A SPOUSE, WHO IS THE ALLEGED VICTIM, IS COMPETENT TO
5 DISCLOSE A CONFIDENTIAL COMMUNICATION BETWEEN SPOUSES OCCURRING
6 DURING THEIR MARRIAGE IN A CRIMINAL ACTION IN WHICH ONE SPOUSE IS
7 CHARGED WITH A CRIME AGAINST THE OTHER SPOUSE.

8 (2) A SPOUSE MAY NOT BE COMPELLED TO TESTIFY TO A
9 CONFIDENTIAL COMMUNICATION UNDER THIS SUBSECTION.

10 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
11 October 1, 2024.
