- 3 FOR the purpose of authorizing the Board of License Commissioners for Baltimore County to approve the transfer of a Class B or Class D license in Election District 15 an 4 5 eligible transferor district existing on a certain date to another election district under 6 certain circumstances; limiting the number of license transfers that the Board may 7 authorize from Election District 15 an eligible transferor district; requiring the Board to notify the county when the Board receives an application to transfer a 8 9 certain license; requiring an application to transfer a certain license to contain 10 certain information; requiring the Board to deny a certain transfer under certain 11 circumstances, subject to a certain exception; authorizing the Board to deny a certain transfer under certain circumstances, subject to a certain exception; repealing as 12 13 obsolete a transfer schedule of Class B and Class D licenses from Election District 15; altering requirements related to the issuance of a Class B Service Bar (SB) 14 15 license; and generally relating to alcoholic beverages in Baltimore County.
